## Application by Norfolk County Council for an Order Granting Development Consent for the Norwich Northern Distributor Road (NDR)

Thank you for your letter of 16 May 2014 regarding the above application.

As we previously mentioned to you in an e-mail of 7 April 2014, unfortunately after the close of the relevant representation period we cannot change any representations made. However, as an interested party, you will be invited to submit further representations over the course of the examination and if you wish to do so, you will be welcome to mark them as from the Cycling Touring Club and they will be published as such.

The Preliminary Meeting is an opportunity for interested parties to hear, and comment on, how the examination will be carried out and their role in it. The Preliminary Meeting is not the place to discuss the details or the merits of the application, there will be opportunities to make representations on these matters during the examination itself. In addition to the initial assessment of principal issues provided at Annex B of the Examining Authority's (ExA's) letter of 8 May 2014, the ExA will outline the procedures for the examination of the evidence (point 3 of your letter).

I'm sorry that you are having difficulty locating documents on our website. When publishing documents to our website we attempt to add descriptions, underneath the title of the document, in the hope that it will assist anyone visiting the website in identifying which documents are relevant to them. In the future you will be able to use the timetable tab to search for documents based on the submission deadline during the examination. The Planning Inspectorate advises that applicants provide a glossary for each written document in order to provide clarification of meaning for all readers including the general public. During the examination of the application the Planning Inspectorate will ensure that it will use complete names and/or phrases before using any acronyms



in all of its procedural letters for the benefit of the reader.

Regarding point 4 of your letter, the Planning Inspectorate aims to conduct a fair, open and impartial examination on behalf of the Secretary of State. The examination is a formal legal process, during which careful consideration is given to all the important and relevant matters, including the representations of all interested parties, any evidence submitted and answers provided to questions set out in writing and explained at hearings. All submissions made by interested parties to the examination of the application will be made publicly available on the Norwich NDR project page of the National Infrastructure pages of the Planning Portal website.
