## The Northern Distributor Route: serious flaws in the consultation process

CPRE Norfolk is seeking your urgent intervention in an issue of serious democratic concern which affects all Norfolk constituents.

As you will know, Norfolk County Council carried out a public consultation exercise last year on the proposed Northern Distributor Road (NDR). CPRE Norfolk, the Norwich Green Party and Stop Norwich Urbanisation (SNUB) all submitted detailed responses to the consultation, objecting to the NDR and raising important concerns about the legal validity of the consultation process. These three important submissions are missing from the County's consultation files. Norfolk County Council claims not to have received them, even though the three groups concerned received auto-acknowledgements at the time of sending.

We are astonished and dismayed that Norfolk County Council could be so negligent in losing these submissions. We cannot say whether it was due to a simple error or deliberate suppression of opposition views, but in either case it is completely unacceptable. Together our organisations represent over 40,000 people and our submissions should have been given appropriate consideration in the consultation process. This has not been allowed to happen.

This is not an issue about the rights or wrongs of the NDR. This is an issue about democratic accountability and whether there has been an abuse of process by Norfolk County Council.

The Planning Inspectorate is expected to make a decision **today** on whether to accept the Development Consent Order for the NDR. We urgently request that, as a parliamentary representative for a Norfolk constituency, you intervene in this process to help ensure that the DCO is refused, on the grounds that there has not been a full and fair public consultation, as required under section 49 of the Planning Act 2008.
