C.1. Introduction

C.3. Section 42(1)(b) Local authorities

C.3.1 Local authorities for the purposes of section 42(1) (b) are defined by section 43 of the *Planning Act 2008* as including those local authorities where the land is within the local authority's area (s43 (1)) (referred to in this Consultation Report as "hosting authorities"). The hosting authorities are made up of unitary councils and lower-tier district councils ("B") and upper-tier county councils ("C") within whose area the land is located.

C.3.2 The Act also includes local authorities ("A") whose area shares any part of its boundary with the boundary of any of the unitary and lower-tier district council hosting authorities' ("B") areas. In addition, it includes local authorities (not lower-tier district councils) ("D") whose area shares any part of its boundary with the boundary of any of the upper tier county council

hosting authorities' ("C") areas ("A" and "D" are referred to in this Consultation Report as "neighbouring authorities").
