Notification of wish to make Oral Representations**

We act for Tarmac (previously known as Lafarge Aggregates Ltd) in respect of the above matter. Please take this as formal notification, as required by the letter from the Examining Authority dated 4 August 2015, that Tarmac wishes to make representations at the following hearings:

- Compulsory Acquisition Hearing dated Wednesday 2 September 2015;
- Compulsory Acquisition Hearing dated Thursday 3 September 2015; and
- Development Consent Order Hearing dated Friday 4 September 2015.

Rebecca Roffe of this office will be in attendance on behalf of Tarmac, alongside representatives from Tarmac itself.

We can confirm that discussions are ongoing between our client and Highways England with a view to a commercial agreement, to avoid the need for the exercise of compulsory acquisition powers associated with the land/mineral over which Tarmac has an interest. However, these discussions are not yet sufficiently progressed to enable us to withdraw our client's substantive submissions and we therefore require the ability to make further representations at the hearings, to protect Tarmac's position in this respect.
