Re: Mrs Maria Hugh- Brooklands House, Alconbury, PE28 4WZ (and Brooklands Bungalow- Mr & Mrs T Peck)

We have seen HE's response to our representations sent in June. We have also seen the updated project design, which introduces a 'bridleway' around the boundary of Mrs Hugh's property with the A1, on which there has been no consultation prior to the publication of the updated design.

We have received an email dated 4 November with assurance from the HE's consultant as follows:

- 1- That a noise barrier will be constructed between the A1 road and the bridleway, on highway land
- 2- That a security fence will be constructed on the boundary of Brooklands House with the highway land
- 3- That there will be consultations with Mrs Hugh on the precise design of the route of the bridleway, to minimise the loss of landscaping, and the existing bund constructed on highway land to mitigate the effect of the previous A1 improvement works

However, whilst this correspondence from the HE is helpful we have the following points for the Inspector to consider

- 1- The need for a bridleway (surely not for horses immediately against the A1) , either for general public recreation or for access to Huntingdon Life Sciences property is not justified , since there is already an adequate public road servicing this property,
- 2- the presence of a bridleway around the boundary of Brooklands House, where at present there is no access, introduces a significant security risk, both from the bridleway itself and from anyone using the drive to Brooklands House (and Brooklands Bungalow) to gain access to the start of the proposed path,
- 3- if the path is removed from the design we are concerned that HE will also remove the noise fence now proposed due to the need to protect the path from the A1, but which is also important to mitigate the effect of noise on Brooklands House
