1 INTRODUCTION

1.1 Introduction

1.1.1 This document provides a guide to Highway England's A19 Testos Junction Improvement (the Scheme) Development Consent Order application pursuant to the Planning Act 2008. The original application was submitted to the Planning Inspectorate on the 14th July 2017, and accepted for examination by the Examining Authority on 10th August 2017.

1.1.2 Since submission, a number of the original application documents have been revised and new documents produced. This guide charts the submission of these documents to the Planning Inspectorate.

1.1.3 This is a live document and will be updated throughout the examination period and submitted, when updated, for each deadline.

1.2 Master Document List

1.2.1 The master document list table commences on page 3 and provides a full list of all the documents submitted to date, indicating either the latest revision (if applicable) or when a new document was submitted.

1	Application Information The completed application form and an introduction to the Scheme as required by the Planning Inspectorate.
2	Plans/drawings/sections Plans that illustrate the location of the Scheme, the proposed works and provide local geographical information.
3	Draft Development Consent Order and Related Documents The legal powers that Highways England is seeking to enable it to build, operate and maintain the Scheme, together with separate documents explaining the provisions of the Order and how other required consents will be obtained.
4	Compulsory Acquisition Information Evidence of why Highways England requires legal powers to compulsorily acquire land, how the Scheme would be funded and details of the land interests that are required for the construction and use of the Scheme.
5	Consultation Report and Related Documents Details of the pre-application consultation that Highways England has undertaken on the Scheme and how consultation feedback has been taken into account.
6	Environmental Statement and Related Documents An assessment of the likely significant effects (both positive and negative) of the Scheme on the environment and a description of mitigation measures proposed to reduce any negative impacts.
7	Other Documents Additional documents that support the DCO application; these are not legally required but provide useful information on the case for the Scheme and/or do not fall into the categories above, including the Transport Assessment.

Highlighted documents are the latest versions and numbers in parentheses refer to the Revision number of the relevant document.
