This is to notify you, on behalf of our client Quintain Limited, which as you know is an Interested Party, that we would like to appear at the Preliminary Hearing on 11 October and, depending on what transpires then, would like to reserve the right to appear at the Issue Specific Hearing (relating to the wording of the DCI) on 12 October, and the Open Floor Hearing on 13 November.
