Application by Transport for London (TfL) for an order granting development consent for the proposed Silvertown Tunnel (the Application)

Southern Gas Networks plc and Birch Sites Limited

We are instructed by Southern Gas Networks plc (SGN) and Birch Sites Limited, which is part of National Grid Property Holdings Ltd (NGP). These are Interested Parties in the examination of the Application whose land is proposed to be compulsorily acquired via the Application.

By way of an update to our previous correspondence in respect of the Application, there have been a number of positive recent meetings between SGN and NGP and the applicant. We envisage that SGN and NGP will have reached an agreement with the applicant and be in a position to withdraw their objections in their capacity as landowners in advance of the compulsory acquisition hearing (CAH) which is scheduled for 29 March 2017.

However, at this stage we reserve our clients' rights to attend the CAH in the event that an agreement with the applicant is forthcoming. We will update you in due course.


