In accordance with the Examination Timetable for the above project, please find below the written submissions of our client, Brenntag UK Limited (also representing the interests of Brenntag Inorganic Chemicals Limited), at Deadline 6.

**Oral submissions made at the Compulsory Acquisition Hearing held on 29 March 2017**

At the above-mentioned compulsory acquisition hearing, it was confirmed that negotiations between our client and Transport for London (TfL) in relation to the detailed terms of a Land and Works Agreement were ongoing. The Examining Authority's acceptance of the non-material changes proposed to the Silvertown Tunnel Scheme by TfL was noted and, once again, confirmation of our client's consent to those non-material changes (particularly, NMC1) was provided. Our client's concern in relation to additional product storage provision within its Tunnel Avenue site was again drawn to the attention of the Examining Authority and it was stated on behalf of our client that no steps had been taken by TfL (as at the date of the hearing) to address this concern, although discussions were continuing.

**Update**

Both parties continue to work towards securing an agreement prior to the close of the Examination, with positive progress having been made over the course of the last week. However, our client will not be in a position to withdraw its representations to TfL's DCO application until an agreement has been reached and the Land and Works Agreement entered into.
