Dear Sirs

We act for the Trustees of Morden College who are landowners on the Greenwich Peninsula. A Statement of Common Ground has been agreed between Transport for London and Morden College and submitted on 10th April 2017. The document correctly sets out in detail those matters that are agreed and not agreed between TfL and Morden College with regard to the examination of the Silvertown Tunnel DCO application.

Unfortunately the document as submitted has a few typographical errors as described hereafter. The contents page (page 4) does not mention all matters not agreed that are set out in pages 19 to 29 of the document. There is reference at paragraph 1.3.7 to a Section 6 in the document with regard to signatures. The document has been agreed between the TfL and Morden College but it was not intended that it would be signed by the parties and the reference at 1.3.7 should have been removed.

We hope this note is helpful for clarification purposes and we confirm it does not otherwise affect the contents of the SoCG.
