Thank you for holding the A38 hearing last week. Here is my statement. Do I need to do anything else?

“Hello I'm Mair Perkins. Thank you for letting me speak. I'm a local resident, I live on Enfield Road behind the McDonalds on the roundabout. I use Markeaton park several times a week for recreation and leisure.

I am concerned about the disruption from years of road works. I'm worried that my husband may be delayed in getting to work and we may be cut off from the city. I'm also worried by increased air pollution levels and more traffic.

But I am very concerned about the harm to the nature in Markeaton Park and the removal of mature trees. With the declaration of a climate emergency, these proposed works should not be going ahead. Mature trees need to be protected for their biodiversity value and for their carbon capture.”
