Application by Highways England for an Order Granting Development Consent for the A38 Derby Junctions project

Procedural Decisions, Variation to the Examination Timetable and Notification of Hearings

On 17 February 2020 the Applicant made two written submissions, which were published to the project website on 18 February 2020. These submissions were considered at the Issue Specific Hearings that were held on 18 and 19 February 2020. The Applicant's submissions and our consideration of them are summarised below.

Notices advertising the Hearings on 18 and 19 February 2020

The Applicant advised that the Notices of the Issue Specific and Compulsory Acquisition Hearings on 18 and 19 February 2020 were not advertised correctly because of an administrative error. The Applicant's submission is available at the following link:

The requirements of Rule 13(6) of The Infrastructure Planning (Examination Procedure) Rules 2010 for notification of hearings have therefore not been followed.

This matter was discussed at Issue Specific Hearing 3. Representations were taken from parties present at that hearing and our decisions were provided to the hearing. An audio recording of the hearing will be published to the project website as soon as is practicable.

In summary, we are satisfied that all Interested Parties were given notification of the Hearings by the Planning Inspectorate more than 21 days in advance and that further notification was provided on the project website. On that basis we decided that the Hearings should go ahead.



We also considered that further action was appropriate to address matters of fairness for any parties that may have been relying on notifications that were not provided in the local press. We therefore decided to hold a further set of Issue Specific and Compulsory Acquisition Hearings. This letter provides the necessary variations to the Examination Timetable and notification of the further Hearings.

Air Quality agenda item at Issue Specific Hearing 4 on 19 February 2020

The Applicant requested removal of the Air Quality agenda item due to an ongoing commission from the Department for Transport that the Applicant considered could have a significant bearing on how it would respond to Air Quality matters raised at the Examination. This matter was discussed at Issue Specific Hearings 3 and 4. Representations were taken from parties present at the hearings and our decisions were provided to the hearings. An audio recording of the hearings will be published to the project website as soon as is practicable.

In summary, we decided that the Air Quality agenda item would not be addressed in full during the Hearing but that any parties present would still be provided with an opportunity to raise any Air Quality matters at the Hearing. In order to provide further opportunities for Examination of this issue we also decided to schedule further dates for the Applicant to clarify its' position, for further written submissions and for an additional Issue Specific Hearing at which Air Quality would be included as an agenda item.

This letter provides the necessary variations to the Examination Timetable and notification of the further Hearings.
