## Summary

### S.1 Overview

- S.1.1 This folio of plans, drawings and sections is submitted to the Secretary of State through the Planning Inspectorate (as responsible agency) in relation to an application made Suffolk County Council ("SCC" / "the Applicant") under section 37 of the Planning Act 2008 ("the Application").
- S.1.2 The application is for an order granting development consent ("the development consent order" / "DCO") for the Lake Lothing Third Crossing scheme ("the Scheme"). The draft DCO is referred to as **The Lake Lothing (Lowestoft) Third Crossing Order 201[\*]**. If made by the Secretary of State, the DCO would grant powers to construct, operate and maintain the Scheme, which comprises a new multi-span single carriageway opening bascule bridge highway crossing, which, via associated approach roads, and new roundabout junctions connecting into the existing highway network, would like the areas north and south of Lake Lothing in Lowestoft. The opening bascule bridge design would enable large vessels to continue to use the Port of Lowestoft; and the scheme includes a bridge control tower on the south quay, as well as a new mooring within the Inner Harbour, for recreational vessels. The Scheme would accommodate all types of vehicular traffic as well as non-motorised user, such as cyclists and pedestrians. It would also include a new access road linking Waveney Drive to Riverside Road, on the south side of the Lake.
- S.1.3 This folio of plans, drawings and sections comprises part of the suite of Application documentation and is included in the Application in compliance with the Infrastructure Planning (Applications: Prescribed Forms and Procedure) Regulations 2009 ("the APFP Regulations").
- S.1.4 All of the plans, drawings and sections in this folio should be read together, and alongside other Application documents, in particular the DCO.
- S.1.5 This folio comprises the following plans, drawings and sections, which comply with the APFP Regulations as set out below:

### S.2 Location Plan – document reference 2.1

- S.2.1 The above-mentioned plan is included in the Application in compliance with APFP Regulation 5(2)(o), which requires the Applicant to provide:

“any other plans, drawings and sections necessary to describe the proposals for which development consent is sought, showing details of design, external appearance, and the preferred layout of buildings or structures, drainage, surface water management, means of vehicular and pedestrian access, any car parking to be provided, and means of landscaping;” (Regulation 5(2)(o))

### S.3 General Arrangement Plans – document reference 2.2

- S.3.1 The above-mentioned plans are included in the Application in compliance with APFP Regulation 5(2)(o), which requires the Applicant to provide:

“any other plans, drawings and sections necessary to describe the proposals for which development consent is sought, showing details of design, external appearance, and the preferred layout of buildings or structures, drainage, surface water management, means of vehicular and pedestrian access, any car parking to be provided, and means of landscaping;” (Regulation 5(2)(o))

### S.4 Land Plans – document reference 2.3

- S.4.1 The above-mentioned plans are included in the Application in compliance with APFP Regulation 5(2)(i), which requires the Applicant to provide:

“a land plan identifying—

- (i) the land required for, or affected by, the proposed development;*
- (ii) where applicable, any land over which it is proposed to exercise powers of compulsory acquisition or any right to use land;*
- (iii) any land in relation to which it is proposed to extinguish easements, servitudes and other private rights; (Regulation 5(2)(i))*

### S.5 Works Plans – document reference 2.4

- S.5.1 The above-mentioned plans are included in the Application in compliance with APFP Regulation 5(2)(j), which requires the Applicant to provide:

“a works plan showing, in relation to existing features —

*(i) the proposed location or (for a linear scheme) the proposed route and alignment of the development and works; and*

*(ii) the limits within which the development and works may be carried out and any limits of deviation provided for in the draft order;" (Regulation 5(2)(j))*

**S.6 Rights of Way and Access Plans – document reference 2.5**

S.6.1 The above-mentioned plans are included in the Application in compliance with APFP Regulations 5(2)(k) and 5(2)(o), which require the Applicant to provide:

*"where applicable, a plan identifying any new or altered means of access, stopping up of streets or roads or any diversions, extinguishments or creation of rights of way or public rights of navigation;" (Regulation 5(2)(k))*

*"any other plans, drawings and sections necessary to describe the proposals for which development consent is sought, showing details of design, external appearance, and the preferred layout of buildings or structures, drainage, surface water management, means of vehicular and pedestrian access, any car parking to be provided, and means of landscaping;" (Regulation 5(2)(o))*

**S.7 Traffic Regulation Measures Plans - document reference 2.6**

S.7.1 The above-mentioned plans are included in the Application in compliance with APFP Regulation 5(2)(o), which requires the Applicant to provide:

*"any other plans, drawings and sections necessary to describe the proposals for which development consent is sought, showing details of design, external appearance, and the preferred layout of buildings or structures, drainage, surface water management, means of vehicular and pedestrian access, any car parking to be provided, and means of landscaping;" (Regulation 5(2)(o))*

**S.8 Classification of Roads Plans – document reference 2.7**

S.8.1 The above-mentioned plans are included in the Application in compliance with APFP Regulation 5(2)(o), which requires the Applicant to provide:

*"any other plans, drawings and sections necessary to describe the proposals for which development consent is sought, showing details of*

*design, external appearance, and the preferred layout of buildings or structures, drainage, surface water management, means of vehicular and pedestrian access, any car parking to be provided, and means of landscaping;" (Regulation 5(2)(o))*

**S.9 Landscaping Plans – document reference 2.8**

S.9.1 The above-mentioned plans are included in the Application in compliance with APFP Regulation 5(2)(o), which requires the Applicant to provide:

*"any other plans, drawings and sections necessary to describe the proposals for which development consent is sought, showing details of design, external appearance, and the preferred layout of buildings or structures, drainage, surface water management, means of vehicular and pedestrian access, any car parking to be provided, and means of landscaping;" (Regulation 5(2)(o))*

**S.10 Engineering Section Drawings and Plans – document reference 2.9**

S.10.1 The above-mentioned plans are included in the Application in compliance with APFP Regulations 5(2)(o), 5(2)(p) and 6(2), which require the Applicant to provide:

*tunnel or underpass which would carry the carriageway or way or through which it would pass.” (Regulation 6(2))*
