

**Foreword** 

This Application Document Tracker relates to an application ("the Application") submitted by Suffolk County Council ("the Applicant") to the Secretary of State (through the Planning Inspectorate) for a development consent order ("DCO") under the Planning Act 2008.

If made by the Secretary of State, the DCO would grant development consent for the Applicant to construct, operate and maintain a new bascule bridge highway crossing, which would link the areas north and south of Lake Lothing in Lowestoft, and which is referred to in the Application as the Lake Lothing Third Crossing (or "the Scheme").



### 1 Introduction

#### 1.1 Purpose of the report

- 1.1.1 This document provides a guide to the Applicant's Development Consent Order application for the Lake Lothing Third Crossing. The application was submitted to the Planning Inspectorate on 13 July 2018 and accepted for examination on 9 August 2018.
- 1.1.2 As part of the examination process some of the original application documents have been revised and new documents produced as a result of representations made. This guide below charts the current status of documents submitted to the Planning Inspectorate/Examining Authority.
- 1.1.3 This is a live document and will be updated throughout the examination period and submitted, when updated, for each deadline.
- 1.1.4 The master document list table provides a full list of all the documents submitted to date.
