## 1. Introduction

Wiltshire Council responded to both the Land Interest Questionnaire and Confirmation of Interests Questionnaire provided by Highways England in relation to this Scheme. However, unfortunately the Council's comments were not incorporated in their entirety from one version to the next. This resulted in a meeting being held between Wiltshire Council and Highways England's consultants, where the Council was assured that the amendments would be reflected in the updated Book of Reference. This has not been the case.

## 2. Wiltshire Council's Comments on Updated Book of Reference

#### Wiltshire Council is listed as a <u>Category 1 Owner</u> in respect of subsoil for the following plots:

05-22	This area is unregistered and so there is no evidence available to the Council to
	confirm the position as to subsoil.
05-25	This area is unregistered and so there is no evidence available to the Council to
	confirm the position as to subsoil.
09-06	This area is unregistered and so there is no evidence available to the Council to
	confirm the position as to subsoil.
09-10	This area is unregistered and so there is no evidence available to the Council to
	confirm the position as to subsoil.
09-15	This area is unregistered and so there is no evidence available to the Council to
	confirm the position as to subsoil.
09-17	This area appears to be registered under title number WT290923; if this is correct
	(it is difficult to tell from the Book of Reference plan for certain), this area of land
	does belong to Wiltshire Council. The reference to subsoil however should be
	removed.
14-09	It is not completely clear from the Book of Reference plan but 14-09 appears to
	include part-registered, part-unregistered land. The part-registered is under title
	number WT290898 which does belong to Wiltshire Council and so reference to
	subsoil in respect of this part of the plot should be removed. The Council is unable
	to confirm the position as to subsoil in respect of the remaining unregistered land,
	due to it being unregistered.

**Please Note:** Wiltshire Council is listed as a Category 1 Owner in respect of apparatus for plots **03-30** and **04-09** (both areas appear to be unregistered and so there is no evidence available to the Council to confirm the position as to apparatus). These may need to be amended to show Wiltshire Council as a Category 2 Owner to ensure consistency with the rest of the document, which shows apparatus ownership as falling with Category 2.

	this site.
05-21	Registered under title number WT274461 but now showing on Wiltshire Council's
	GIS mapping and no deeds / files relating to this title number on the Council's
	database – there is therefore no evidence that Wiltshire Council owns apparatus on
	this site.
05-26	This area appears to be unregistered and so there is no evidence available to the
	Council to confirm the position as to apparatus.
09-06	This area appears to be unregistered and so there is no evidence available to the
	Council to confirm the position as to apparatus.
09-08	Registered under title number WT277549 but not showing on Wiltshire Council's
	GIS mapping and no deeds / files relating to this title number on the Council's
	database – there is therefore no evidence that Wiltshire Council owns apparatus on
	this site.
09-15	This area appears to be unregistered and so there is no evidence available to the
	Council to confirm the position as to apparatus.
09-18	Registered under title number WT277549 but not showing on Wiltshire Council's
	GIS mapping and no deeds / files relating to this title number on the Council's
	database – there is therefore no evidence Wiltshire Council owns apparatus on this
	site.
09-29	Registered under title number WT47032 but not showing on Wiltshire Council's GIS
	mapping and no deeds / files relating to this title number on the Council's database
	- there is no evidence Wiltshire Council owns apparatus on this site.
11-02	This area appears to be unregistered and so there is no evidence available to the
	Council to confirm the position as to apparatus.
14-04	This area appears to be unregistered and so there is no evidence available to the
	Council to confirm the position as to apparatus.
14-06	Registered under title number WT87750 but not showing on Wiltshire Council's GIS
	mapping and no deeds / files relating to this title number on the Council's database
	- there is therefore no evidence Wiltshire Council owns apparatus on this site.
14-07	As 14-06 above.

## 3. Conclusion

The Council is of the position that the comments contained above should be reflected in an amended Book of Reference to be submitted into Examination at an appropriate time. The Council notes that a further submission of the Book of Reference is not expressly requested within the Examination Timetable at present.
