### Stone Curlew Plot Update

As confirmed at Issue Specific Hearing 11 on 30 August 2019, a variety of landowners have been identified and we have received positive responses to the provision of stone curlew sites on their land. Draft agreements have been issued to four landowners. All these sites have been confirmed as suitable by RSPB. As stated by Natural England at ISH 7 (on 14 June 2019), there is a sufficient number of suitable sites and willing landowners, hence the commitment to provide the sites is enough to give the certainty of the sites being in place. The progress to date is evidence of this. The Applicant aims to have the agreements with landowners in place by the end of examination and a further update on this matter will be provided at Deadline 9 as part of the response to the Rule 17 letter issued on 3 September 2019. Even if this process has not been completed before the end of examination there is still sufficient certainty that agreements can and will be secured with landowners well in advance of any possibility of impact of the Scheme.
