Stone Curley Update

Please find enclosed Highways England's response to the Rule 17 letter dated 3 September regarding Stone Curlews. As stated at Deadline 8, Highways England had aimed to have agreements with landowners in place by the end of the examination period but it is now hoped that Highways England will be in a position to submit these agreements within the next couple of weeks, as positive discussions with landowners are continuing. However, as explained in the response to the Rule 17 letter, even if agreements have not been completed before the end of the examination there is still sufficient certainty that agreements can and will be secured with landowners, securing the provision of the stone curlew plots, due to the inclusion of a new requirement in the dDCO submitted at this Deadline, which addresses these matters. This refers to a 'stone curlew breeding plot specification' which has also been submitted at this Deadline and is proposed to be certified under the dDCO. Please note two copies of this document are provided, one of which contains a confidential plan which is not for release on the PINS website.

An updated and final 'Consolidated Environmental Mitigation Schedule' (CEMS) and 'Outline Environmental Management Plan' (OEMP)

In addition, please find enclosed both a clean and two tracked versions of the final Outline Environmental Management Plan ("OEMP"). This document updates revision 5 of the OEMP [REP8-006] submitted at Deadline 8 and incorporates further amendments made following comments and discussions with stakeholders. The first tracked change version shown the changes since the Deadline 8 submission [REP8-006] and the second since the original submission [APP-187].

An updated final version of the Detailed Archaeological Mitigation Strategy (DAMS) A clean and tracked changed version of this document is enclosed, which replaces the one submitted at Deadline 8 [REP8-008]. This document incorporates further changes made following receipt after Deadline 8 of further comments from stakeholders and subsequent discussions with them.

Statements of Common Ground Update

Whilst it is noted that final Statements of Common Ground were programmed to be submitted at Deadline 7, the finalisation of key documents such as the tunnel covenant, OEMP and DAMS has meant that matters are continuing to be progressed through the Examination. To highlight this progress and to ensure that relevant information is accessible for the Examining Authority, the following clarification update is provided.



Statement of Common Ground	Status
English Heritage Trust (8.1)	It is intended that a revised final version of the Statement of Common Ground will be submitted before the close of examination on 2 nd October.
Environment Agency (8.2)	A revised final version of the Statement of Common Ground has been submitted at Deadline 9.
Historic England (8.3)	It is intended that a revised final version of the Statement of Common Ground will be submitted before the close of the examination on 2 nd October.
National Farmers Union (8.4)	It is intended that a revised final version of the Statement of Common Ground will be submitted before the close of examination on 2 nd October.
National Trust (8.5)	It is intended that a revised final version of the Statement of Common Ground will be submitted before the close of examination on 2 nd October.
Natural England (8.6)	A final and signed version of the Statement of Common Ground [AS-106] has been submitted and accepted as an additional submission.
Royal Society for the Protection of Birds (8.7)	A final and signed version of the Statement of Common Ground [AS-104] has been submitted and accepted as an additional submission.
Wiltshire Council (8.8)	It is intended that a revised final version of the Statement of Common Ground will be submitted before the close of the examination on 2 nd October.
Winterbourne Stoke Parish Council (8.9)	No further updates are being made to the Statement of Common Ground. Therefore, the point of reference remains the Deadline 7 version of the Statement of Common Ground [REP7-017] and the Statement of Common Ground – Progress report submitted at Deadline 8 [REP8-021].
Landowners, [Messrs Francis & Louise Whiting], Robin Parsons, [Stephen Moore], Philip Sawkill and Pamela Sandell	We were due to submit Landowner Statements of Common Ground for Parsons, Sawkill & Sandell (mentioned in Deadline 8 covering letter) which were based on our position statements. However, the landowner's agent has now confirmed that these will revert back to position statements and will not be submitted to the ExA.

Status of Discussions with Wiltshire Council

The Applicant has now reached agreement with Wiltshire Council on the terms of the legal agreement between the parties which deals with a number of items, including the detailed mechanics relating to the highways to be de-trunked, and local highways to be constructed or improved, under the DCO, amongst other things. The parties are in the process of going through their respective execution processes and are seeking to formally complete the legal agreement before the end of the examination or as soon as possible thereafter. The parties will provide an update when this process is complete and the agreement is in place.
