I write with reference to my letter of 11 January 2022 providing the response from National Highways to the Secretary of State for Transport's Statement of Matters. This earlier letter noted that National Highways intended to submit further reports. These reports were referenced in our response to Bullet Point Four of paragraph 2 of the Statement of Matters, the Environmental Information Review.

Today's letter provides a list of these reports that now have been submitted to the Secretary of State. This list is in the table on the next page. Please note that two reports - Badger Sett Survey Report (2021) (document number 2.5) and Parsonage Down Stone Curlew Plot – Botanical Survey Report (2021) (document number 2.10) – contain confidential information. We also have submitted additional reports that were not referenced in our response to the Statement of Matters. This information was recently issued (January 2022) under a Freedom of Information request. We are making this information submitted today available to all interested parties. One of the documents - Groundwater Monitoring Data (document number 2.24) – is provided as a zip of Excel workbooks rather than in PDF format due to the amount of data and arrangement into different workbooks and sheets. We have password protected the workbooks.
