Thank you for your letter of 25 February 2022 highlighting the proposed application by National Highways for an Order Granting Development Consent for the proposed A303.

The A303 is located within the administrative area of Wiltshire Council and is for the creation of a two-lane dual carriageway on the A303 trunk road between Amesbury and Berwick Down. This scheme falls outside Oxfordshire's boundary.

We note that a Statement of Matters was issued on 30 November 2021 relating to the Secretary of State's re-determination of the Application. A number of updated baseline reports were submitted on 8 February 2022.
