Subject Objections to the Proposed Widening of A303 Roadway near Stonehenge

Dear Mr Shapps,

For the important and urgent reasons briefly outlined in this email message, I hope you will please agree to cancel, or at least modify, the proposed widening of the A303 road near Stonehenge.

- 1. Please ban the proposed dual-carriageway, because it would gouge deeply and destructively into the archeological landscape of this internationally acclaimed World Heritage Site.
- 2. Even if the widening of A303 is forced on you politically, please at least change the scheme to heed Unesco's advice (22 July 2021) that Stonehenge's world-heritage status might be reduced.
- 3. Any decision about A303 needs to take careful heed of the UK's Environment Act 2021 and of the recent reports by the UN's Intergovernmental Panel on Climate-Change.
- 4. Research by CPRE (Campaign to Protect Rural England) has shown that building faster roads rarely brings economic benefits to a region.
- 5. Official statements already acknowledge that the impact of the proposed widening of A303 would be "significantly adverse".
- 6. Instead of altering this roadway, the best option is to keep the existing A303 as it is, so that the UK Government will thereby demonstrate its commitment to environmental wisdom.
- 7. To incentivize safe driving throughout Britain, please stop widening any roads, and please use the A303 as an example of how to promote safety by lowering all the speed-limits everywhere.
- 8. For Britain to help in the worldwide necessity of protecting the atmosphere against carbon, please use the prestige of Stonehenge to publicize this environmental responsibility.
- 9. There is an urgent need to assess alternative routes (eg: a southern bypass or a longer tunnel) before making any commitment to the current proposal.
- 10. There is an even more important need to consider alternatives to hard engineering, such as measures to reduce the road-traffic and/or to reduce the carbon-emissions.
- 11. Please arrange for the Development Consent Order (DCO, October 2019) to be re-examined by an independent panel, before any further decisions are made about the A303.
- 12. Before altering the A303 in any way, please re-estimate all aspects of current and future costs, as these have probably increased as a consequence of worldwide inflation and the war in Ukraine.
