Updated Draft DCO

Western Power Distribution has requested that the company named in Article 10 be changed to Western Power Distribution (South West) PLC. Highways England does not consider that this is necessary by virtue of the existing wording which refers to related or subsidiary companies, but is nonetheless content to make this amendment which it requests is included in the final DCO.

Due to the late nature of this request, the clean version and the validation report for the DCO will be submitted for acceptance at the discretion of the Examining Authority on 16 July 2019.

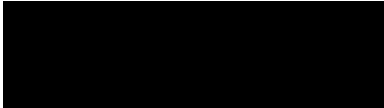
