1 Introduction

1.1 Purpose of this document

- 1.1.1 This document provides a guide to Highways England's A30 Chiverton to Carland Cross Development Consent Order application. The original application was submitted to the Planning Inspectorate on 30 August 2018 and accepted for examination by the Examining Authority on 27 September 2018.
- 1.1.2 Since submission a number of the original application documents will continue to be revised and new documents produced. This guide provides a list of the latest documents submitted at deadline 3.
- 1.1.3 This is a live document and will be updated throughout the examination period and submitted for each deadline.
