Written Representation of Cadent Gas Limited**

We act for Gas Cadent Limited and write further to our written representations dated 11 October 2019.

Our client and the Promoter are still in the process of negotiating the form of the protective provisions for inclusion in the Order.

The Promoter has proposed a number of drafting amendments to Cadent's standard form protective provisions which it has been explained to us are simply intended to bring them in line with the drafting of Order. Until that correspondence (by e-mail of 30 October 2019), we had understood the protective provisions were very close to being in agreed form. We are reviewing these amendments and are aiming to have an agreed set of protective provision, which the parties would propose is included on the face of the Order, by Deadline 9 which is on the 15 November.
