M25 junction 28 improvement scheme
Statutory consultation – 03 December 2018 until 28 January 2019
Section 46 Notification under the Planning Act 2008 (as amended) of a proposed Development Consent Order application

I am hereby notifying you that, under Section 46 of the Planning Act 2008, Highways England ("the applicant") intends to apply under Section 37 of the Planning Act for a Development Consent Order (DCO) for the M25 junction 28 improvement scheme.

The scheme involves the provision of a new two lane loop road between the M25 anticlockwise and the A12 eastbound carriageways and constitutes a Nationally Significant Infrastructure Project (NSIP) under Section 22 of the Planning Act 2008 (as amended).

Highways England will be undertaking pre-application consultation under Section 42 of the Planning Act 2008 between **03 December 2018** and **28 January 2019**.
