As Programme Leader, Regional Investment Programme (South) for Highways England, I have signed the certificates.

It has been necessary to update the Section 56 Certificate of compliance, to reflect the additional parties on whom Section 56 notices have recently been served as outlined in our letter dated 8 October 2020 ([AS-019](#)). The affected parties are detailed in the Schedule to the updated Certificate of Compliance with Section 56 of Planning Act 2008. These parties have been included in the recently submitted revised versions of the Book of Reference ('clean' version [AS-021](#) and 'track changed' version [AS-023](#)).

These parties were issued with letters ([AS-018](#)) advising them of the accepted application and a Section 56 notice ([AS-020](#)). These letters directed the recipients to further information on the scheme, including the online version of the application documents and to the Section 56 notice for details on how to make representations regarding the Scheme. The letters and notices stated that, as agreed with the Inspectorate, a form would be available on the Inspectorate's web site for those parties to submit representations by 11.59pm on Friday 30 October 2020.

A revised Section 56 notification list is also provided with this letter. This list has been amended to include (i) those parties served with the additional Section 56 notices and (ii) 18 other parties who were originally served with Section 56 notices (in July 2020) but were erroneously omitted from the notification list previously provided.

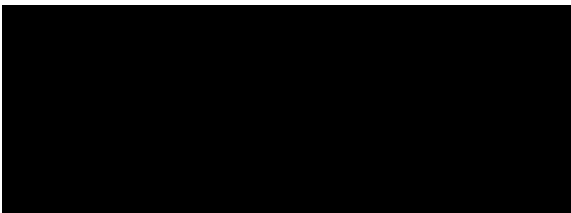
An updated Certificate of compliance with Section 59 of the Planning Act 2008 is also enclosed together with, for completeness and in accordance with part (b) of that certificate, a clean and track changed version of the updated Book of Reference ('clean' version [AS-021](#) and 'track changed' version [AS-023, as recently submitted](#)).

Similarly, an updated Certificate of compliance with Regulation 16 of the EIA Regulations is also enclosed, in view of the submission of the updated Section 56 Certificate of compliance and in accordance with regulation 17(b) of the EIA Regulations.

The updated Certificates of compliance enclosed are intended to replace those provided on 11 September 2020.
