Further to my letter of 13 April 2021, Highways England hereby submits a request for the following change to the Scheme (the Proposed Change) to be accepted for examination:

Change 8 – Grove Farm egress – revisions to Work No. 15.

Further information regarding the Proposed Change, together with an assessment of its likely significant environmental effects, can be found in the documents accompanying this application. A list of the accompanying documents is set out in Table 1 below.

In preparing the documents to accompany this application, Highways England has had regard to the advice contained in the Planning Inspectorate's Advice Note 16 (How to request a change which may be material).
