Dear Edwin, as you are aware from our previous exchanges I am instructed to act on behalf of Luddington Golf Ltd ('LGL'), LGL being the owners of the leasehold interest in Maylands Golf Course, and on whose behalf I made a Written Representation against the above scheme on 4th February 2021.

During the course of the previous weeks LGL and Highways England ('HE') have reached a provisional agreement in respect of the accommodation works necessary for the continuance of the golf course: which agreement is now in the process of being formalised. LGL is therefore pleased to confirm that it is satisfied with the arrangements proposed by HE as the Applicants Change Request 7.

Furthermore as Change Request 7 meets all the concerns set out in LGL's Written Representation and as LGL has HE's assurance that HE will conclude the formal agreement referred to above, please accept this communication as formal notice that the Written Representation opposing the improvement scheme made by LGL is withdrawn.

Under the circumstances therefore, would you please advise the Examining Authority that LGL does not intend to appear at the Issue Specific Hearing 3 set for Wednesday 12th May 2021.
