We apologise for this omission.

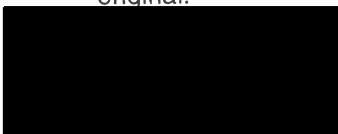

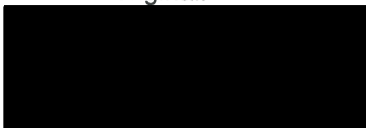

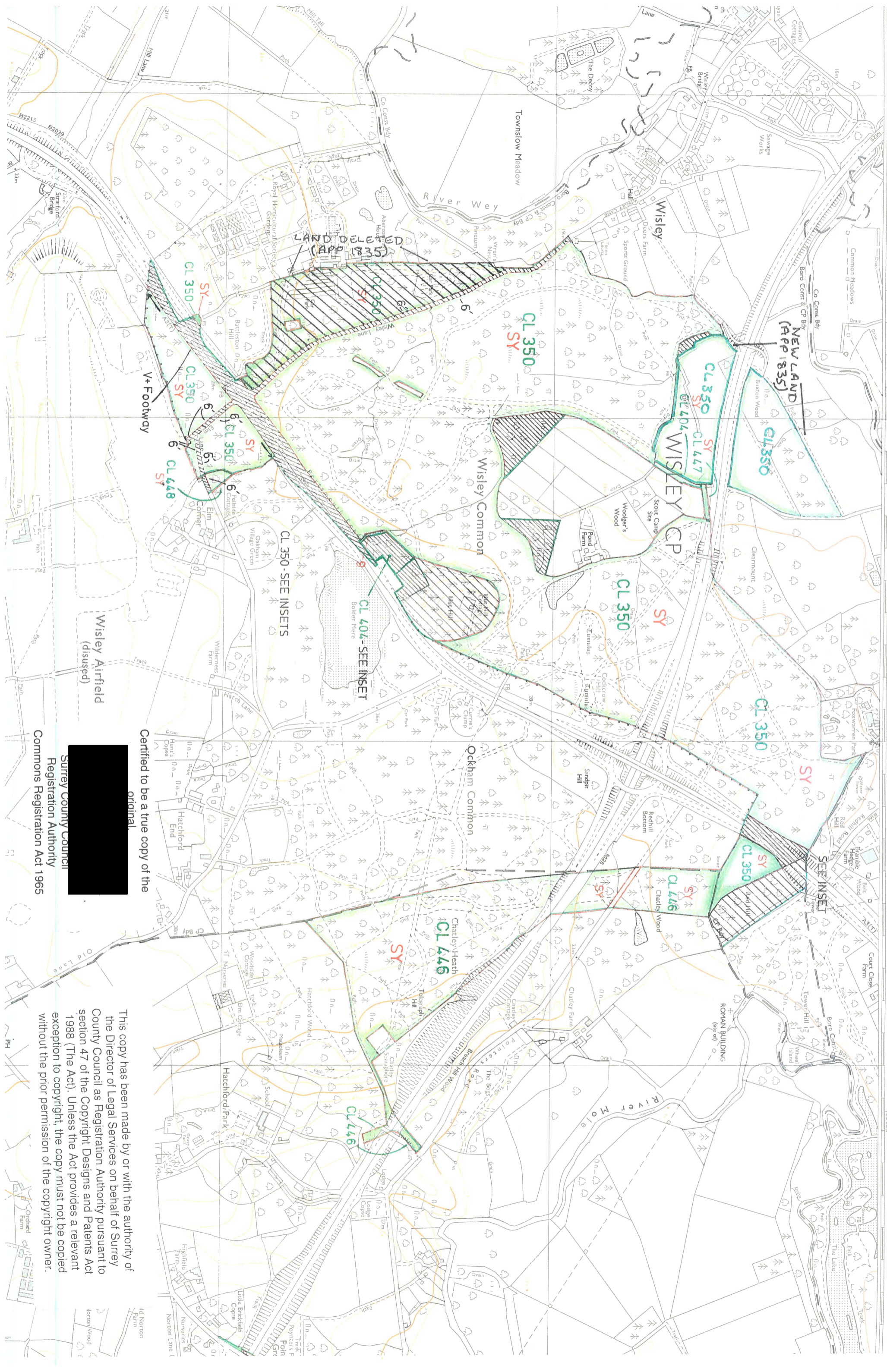
