Highways England's Deadline 4 submission –11 February 2020

- Action Point 5 – Visibility splay drawings. Highways England has integrated this action point into (Highways England's Comments on Surrey County Council's Deadline 3 Submission (document reference **TR0130030/Volume 9.52**).

- Action Point 15 – Following ISH2, Highways England met with the Painshill Residents Association on 23 January 2020. The Association has subsequently submitted a letter [REP3-064] confirming the same.

3. Statutory Undertaker Representations with regard to section 127 Planning Act 2008 (Rev 2)

As requested by the Examining Authority in ExAQ1 1.16.5, Highways England has provided a schedule of statutory undertaker representations to which section 127 of the Planning Act 2008 applies. This was submitted initially at Deadline 2 as REP2-020 and was updated for Deadline 3 as REP3-005. At Deadline 4 this document (**TR0130030/Volume 9.25(1) [REP3-005]**) has not been submitted as there are no updates since Deadline 3.

4. Statutory Undertaker Representations with regard to section 138 Planning Act 2008 (Rev 2)

As requested by the Examining Authority in ExAQ 1.16.6, Highways England has provided a schedule of statutory undertaker representations to which section 138 of the Planning Act 2008 applies. This was submitted initially at Deadline 2 as REP2-021 and was updated for Deadline 3 as REP3-006. The update at Deadline 4 is under document reference **TR0130030/Volume 9.26(2)**.

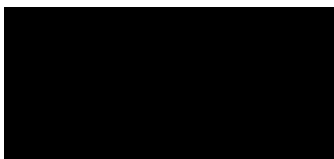
5. A revised Guide to the Application
