1. Introduction

- 1.1.1 This document sets out Highways England's comments on the Deadline 3 submission [REP3-028] from Extra MSA Cobham Limited (received on 28 January 2020).
- 1.1.2 Where issues raised within the submission have been dealt with previously by Highways England, for instance in response to a question posed by the examining authority in its first round of written questions [REP2-013], in Highways England's comments on written representations [REP2-014] or within one of the application or other examination documents, a cross reference to that response or document is provided to avoid unnecessary duplication. The information provided in this document should, therefore, be read in conjunction with the material to which cross references are provided.
- 1.1.3 In order to assist the examining authority, Highways England has not provided comments on every point made by Extra MSA Cobham Limited including for example statements which are matters of fact and which it is unnecessary for Highways England to respond to. However, and for the avoidance of doubt, where Highways England has chosen not to comment on matters contained in the response, this should not be taken to be an indication that Highways England agrees with the point or comment raised or opinion expressed.



2. Extra MSA Cobham Limited Response

- 2.1.1 Extra MSA Cobham Limited, in its Deadline 3 response [REP3-028], have overall accepted most of Highways England's positions on issues in responses to Relevant Representation at Deadline 1 [REP1-009] and in response to their Written Representation [REP2-014]. Extra MSA Cobham Limited have also indicated that they will continue to work with Highways England on a number of matters.
- 2.1.2 It only has concerns around one remaining issue. Extra MSA Cobham Limited state that "Extra requests confirmation that Highways England will indemnify Extra against all costs incurred in relation to relocation or replacement of the traffic sign."
- 2.1.3 Highways England can confirm that they will reimburse reasonable costs incurred in relation to relocation of replacement of the traffic sign.
