Comment on Proposed Change 7 - Painshill Park Trust

Painshill Park Trust supports Proposed Change 7 (Optional Alternative Private Means of Access to Court Close Farm through Heyswood Campsite). It will protect the Girl Guide's use of the campsite and at the same time facilitate the provision of a substitute for the Trust's existing access onto the A3 which Highways England intends to close.

A substitute entrance to Painshill, which Highways England had previously promised to provide, is essential to the survival and continued restoration of Painshill Park, a Grade 1 Registered Landscape and one of the foremost surviving examples of an 18th Century English Landscape Garden.
