1. Introduction

- 1.1.1 This document sets out Highways England's response to the Examining Authorities request from Session 2 Part 6 Former Wisley Airfield to:
 - Submit a note (either to be agreed jointly, or separately by each party if such agreement cannot be reached) setting out the envisaged key timetabling dates for both the Proposed Development and the airfield redevelopment project.
- 1.1.2 Programme discussion have been held between Highways England, Balfour Beatty Atkins and WIPL teams and a combined programme produced.
- 1.1.3 During 2021 and the construction of the Wisley Lane diversion running through to Q3 2022 access will not be available via Ockham Junction.
- 1.1.4 WPIL's position is that, given that the DCO will remove their existing access to the Airfield from Elm Lane and the ability to use access provided for by the implemented In Vessel Composting (IVC) planning consent, it is essential to agree provision for WPIL's construction access to the Airfield via Elm Lane / Ockham Interchange / the DCO worksite. This access needs to be agreed for the duration of the DCO works to enable preparatory and other works to be undertaken and ensure timely delivery of housing (in accordance with GBC adopted local plan housing trajectory) and avoid the delivery of the development being stymied or delayed.
- 1.1.5 Highways England note WPIL's position in this regard, and as such, access arrangements during this time frame will be collaboratively agreed between both parties so works can progress for both schemes.
- 1.1.6 This is a combined programme agreed between Highways England and WPIL.
