In response to your question in relation to land referencing, the references to HF1 and HF2 correspond to the following:

- Hatchford End 1: a 1.18ha field near Hatchford End; and
- Hatchford End 2: 0.55ha of land forming part of a field near Hatchford End

With regard to Post Examination Correspondence, this will all be published alongside the decision.
