

1 INTRODUCTION

1.1 Purpose of this document

- 1.1.1 This Guide to the Documents to be Certified (this "Guide") relates to an application made by Highways England (the "Applicant") to the Planning Inspectorate (the "Inspectorate") under the Planning Act 2008 (the "2008 Act") for a Development Consent Order (DCO). If made, the DCO would grant consent for the Applicant to undertake the A1 Birtley to Coal House (the "Scheme"). A detailed description of the Scheme can be found in **Chapter 2** of the Environmental Statement (ES) (**Application Document Reference:** TR010031/APP/6.1).
- 1.1.2 The purpose of this Guide is to help the Examining Authority and interested parties understand the draft DCO through identifying the latest version of any document that it is to certify. It also aims to help the Examining Authority and interested parties understand the parameters for implementing the DCO and how it will be implemented.
- 1.1.3 This Guide has been submitted with the application and will be updated where necessary throughout the Examination to confirm:
 - Any revised versions of any application documents; and / or
 - Any additional documents produced since submission of the application

that would be certified documents were the Secretary of State to grant development consent on the basis of the DCO as drafted at the point of issue of this Guide.
