

#### 1 INTRODUCTION


#### 1.1 Purpose of this Document


- 1.1.1 The General Arrangement Plan (the "Plan") relates to an application made by Highways England (the "Applicant") to the Planning Inspectorate (the "Inspectorate") under the Planning Act 2008 (the "2008 Act") for a Development Consent Order (DCO). If made, the DCO would grant consent for the Applicant to undertake the A1 Birtley to Coal House (the "Scheme"). A detailed description of the Scheme can be found in **Chapter 2** of the Environmental Statement (ES) (Application Document Reference: TR010031/APP/6.1).
- 1.1.2 The Plan comprises part of the suite of Application documentation and is included in the Application in compliance with Regulation 5(2)(o), of the Infrastructure Planning (Applications: Prescribed Forms and Procedure) Regulations 2009 (the "2009 Regulations"), which requires:
  - "5(2)(o) any other plans, drawings and sections necessary to describe the proposals for which development consent is sought, showing details of design, external appearance, and the preferred layout of buildings or structures, drainage, surface water management, means of vehicular and pedestrian access, any car parking to be provided, and means of landscaping"
- 1.1.3 This Plan is also being submitted under Regulation 5(4) of the 2009 Regulations which states:
  - "Where a plan comprises three or more separate sheets a key plan must be provided showing the relationship between the different sheets."
- 1.1.4 As the Plan is part of the Application documentation, it should be read alongside and is informed by the other Application documents. In particular, the Plan should be read alongside Schedule 1 of the draft DCO (Application Document Reference: TR010031/APP/3.1), the Engineering Section Drawings (Application Document Reference: TR010031/APP/2.5) and the Structures Engineering Drawings and Sections (Application Document Reference: TR010031/APP/2.7).





