## **NGN Statement of Common Ground**

Having liaised closely with NGN, the Applicant is continuing to negotiate protective provisions and these are well advanced with a limited number of issues to resolve. Having spoken to NGN's solicitors, we have agreed that we should progress negotiations regarding the change proposal and the protective provisions during the course of this week and provide a more complete update for the ExA at Deadline 5, by which time we hope to have substantially agreed the Statement of Common Ground.
