Dear Sirs,

Northumbrian Water Limited ("NWL") has agreed the contents of the draft Statement of Common Ground to be submitted by the Applicant at this deadline. In so far as there is any inconsistency between the SOCG and the Position Note for the Hearings submitted by NWL two weeks' ago, the SOCG reflects the current position as at today's date.

NWL considers that it is near agreement with the Applicant on the Protective Provisions and a side agreement covering other protective measures. It hopes to have agreed these documents by the end of the Examination process. At this stage, NWL does not, therefore, think it appropriate to submit to the Examining Authority any alternative wording for the Protective Provisions.

In response to the Examining Authority's letter of 24 June 2020 in relation to the Unaccompanied Site Inspection, NWL would like to draw the Examining Authority's attention to the following locations at which NWL's large 37" Derwent main interacts with the Scheme. At location 6 on the Itinerary (Smithy Lane Bridge), the pipeline crosses the A1. At location 7 (Lamseley Village), the pipeline cross the corner of the additional land included for a site compound.
