1 INTRODUCTION

1.1 Purpose of this document

- 1.1.1 This Application Document Tracker (this "Tracker") relates to an application made by Highways England (the "Applicant") to the Secretary of State for Transport via the Planning Inspectorate (the "Inspectorate") under the Planning Act 2008 (the "2008 Act") for a Development Consent Order (DCO). If made, the DCO would grant consent for the A1 Birtley to Coal House (the "Scheme"). A detailed description of the Scheme can be found in **Chapter 2** of the Environmental Statement (ES) [**APP-023**].
- 1.1.2 The purpose of this Tracker is to help the Examining Authority and interested parties understand the draft DCO through identifying a list of all documents submitted by the Applicant.
- 1.1.3 An updated version of this Tracker will be submitted for each Examination Deadline to reflect updates to other submission documents. This Document is submitted for **Deadline 11** (17 July 2020, Rev 3).
