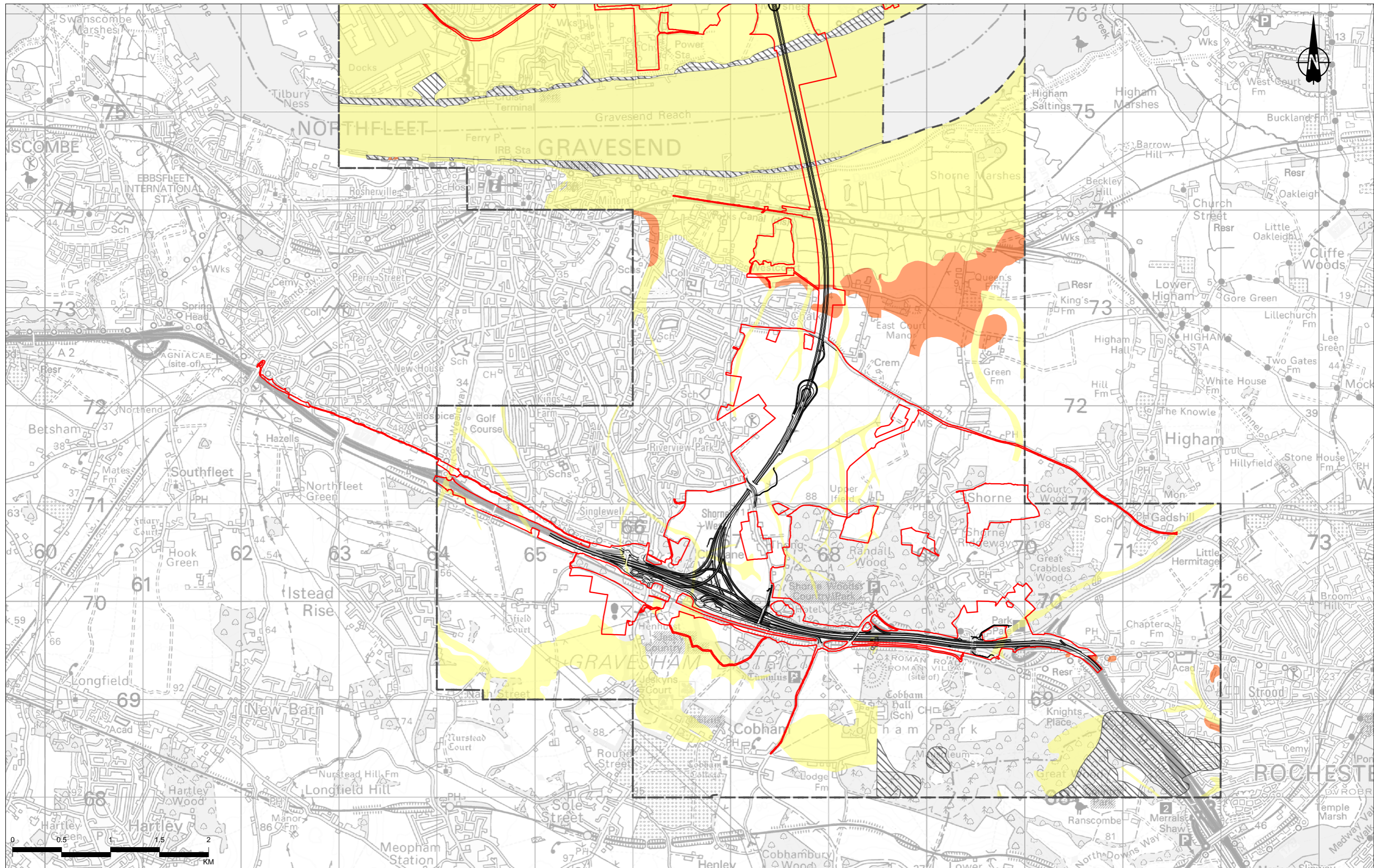
### Figure 14.3 - Superficial Aquifer Designations

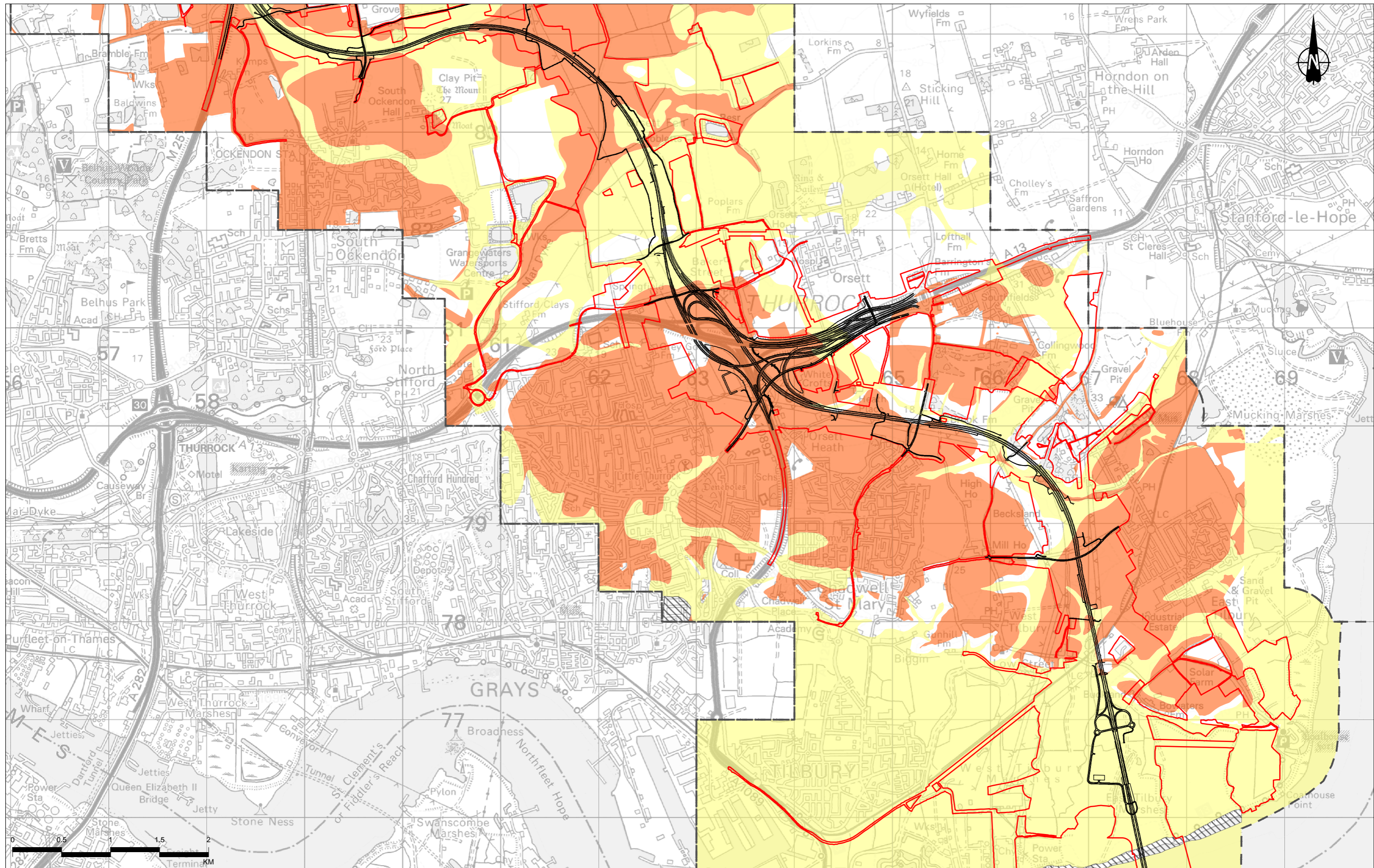

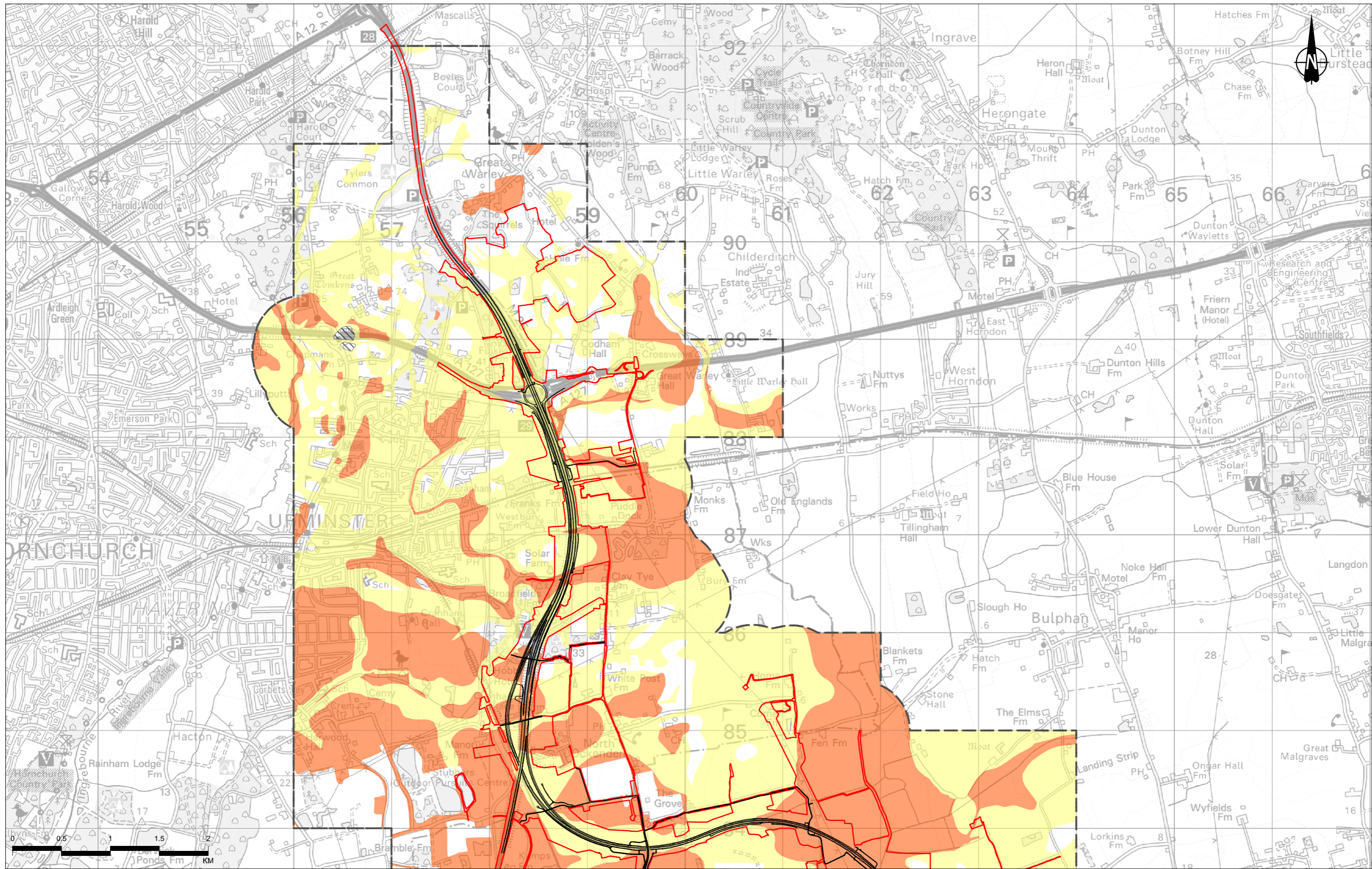
