### Figure 14.4 - Bedrock Aquifer Designations

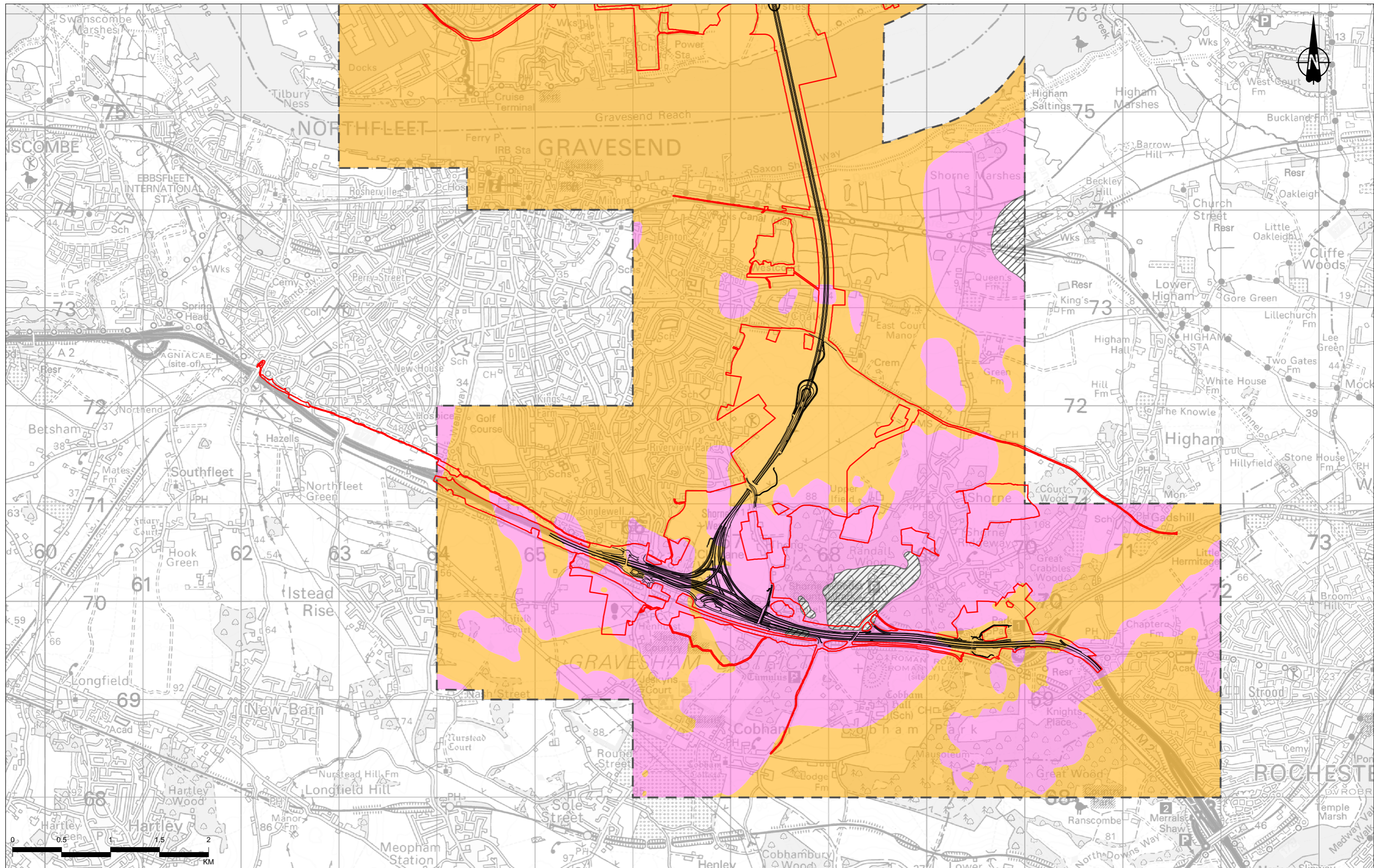
