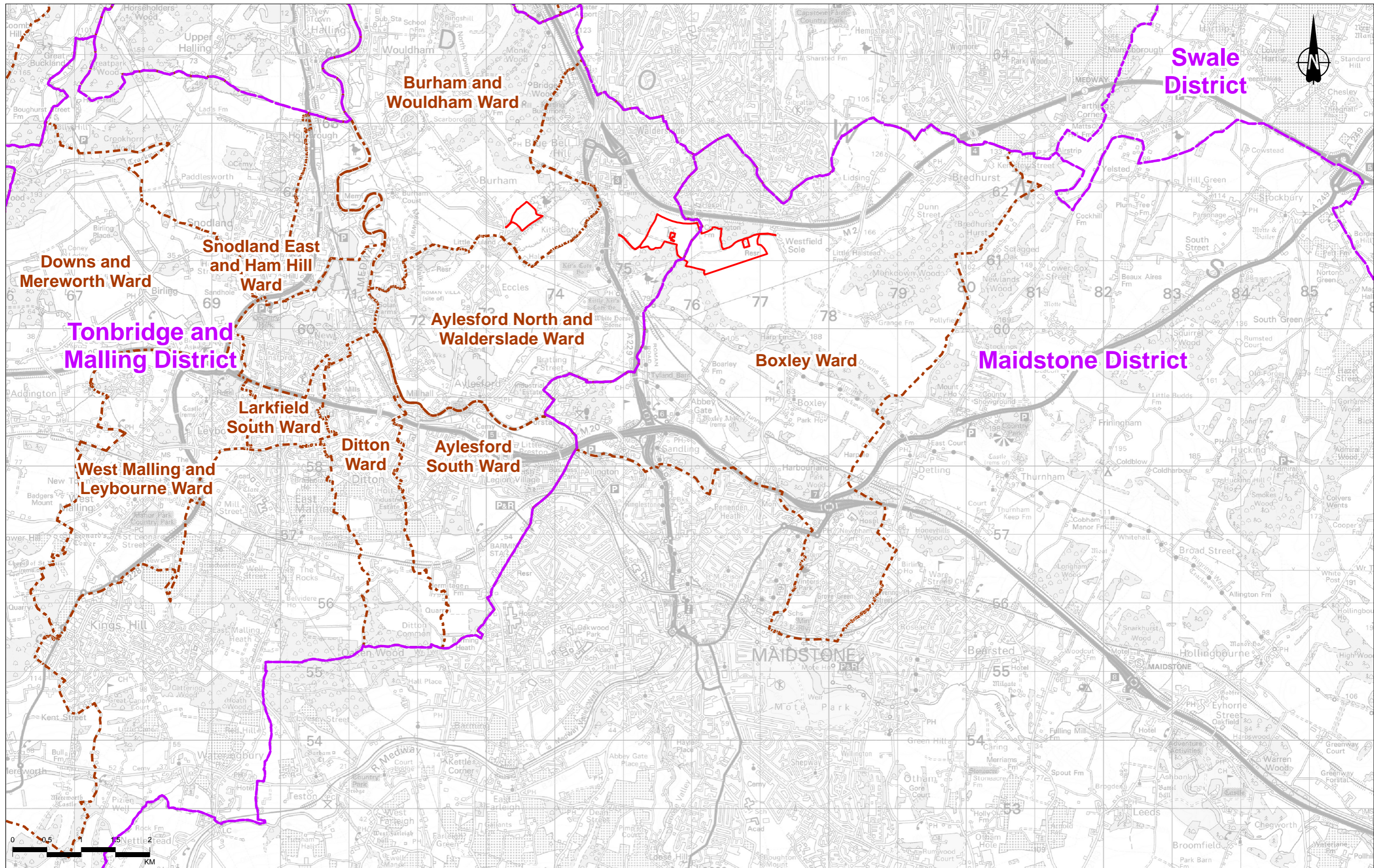
Figure 16.3 - Overview Map of Local Authorities and Wards

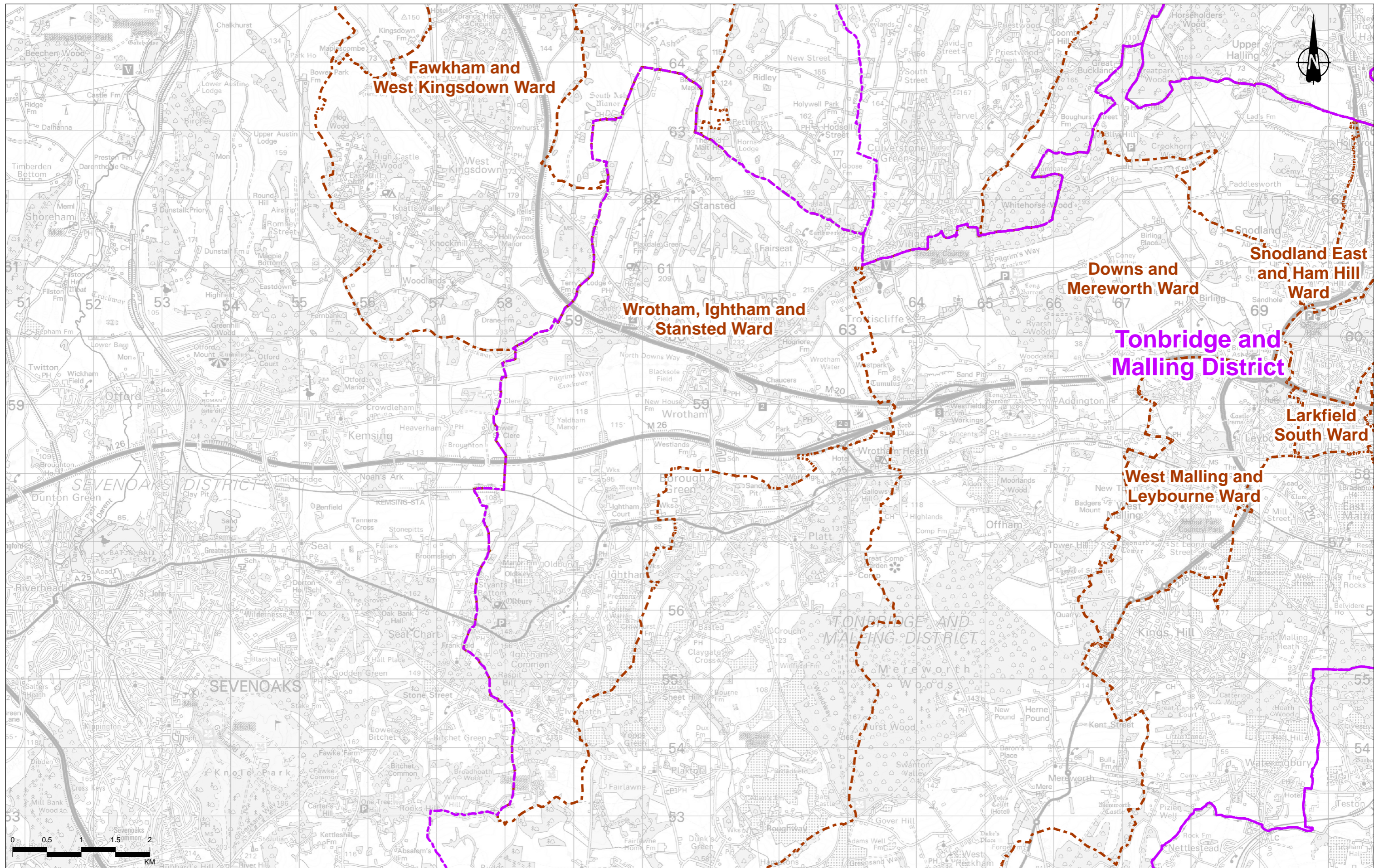

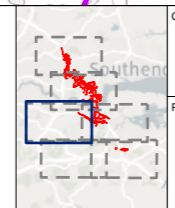

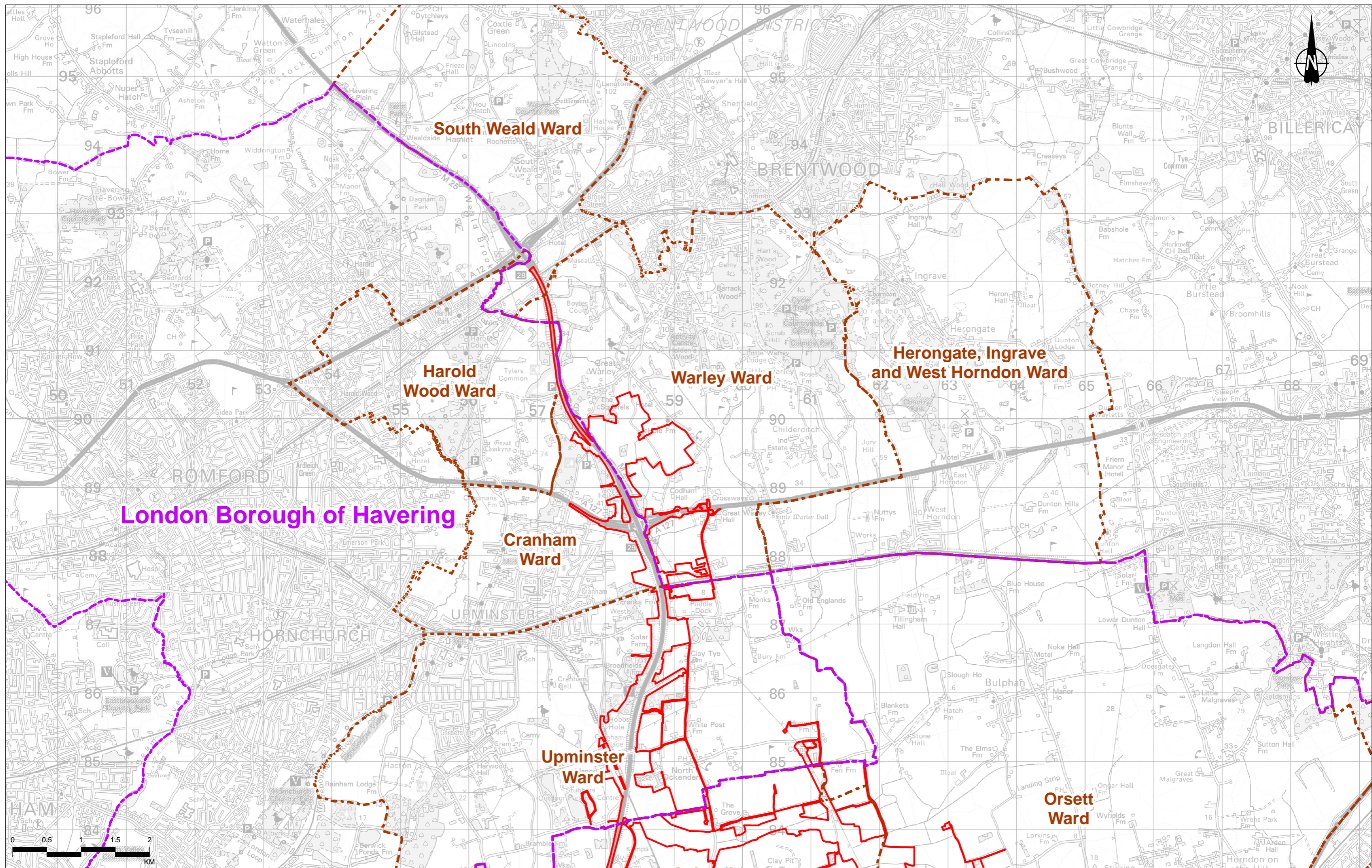

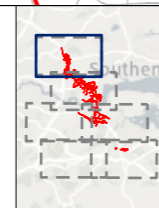
