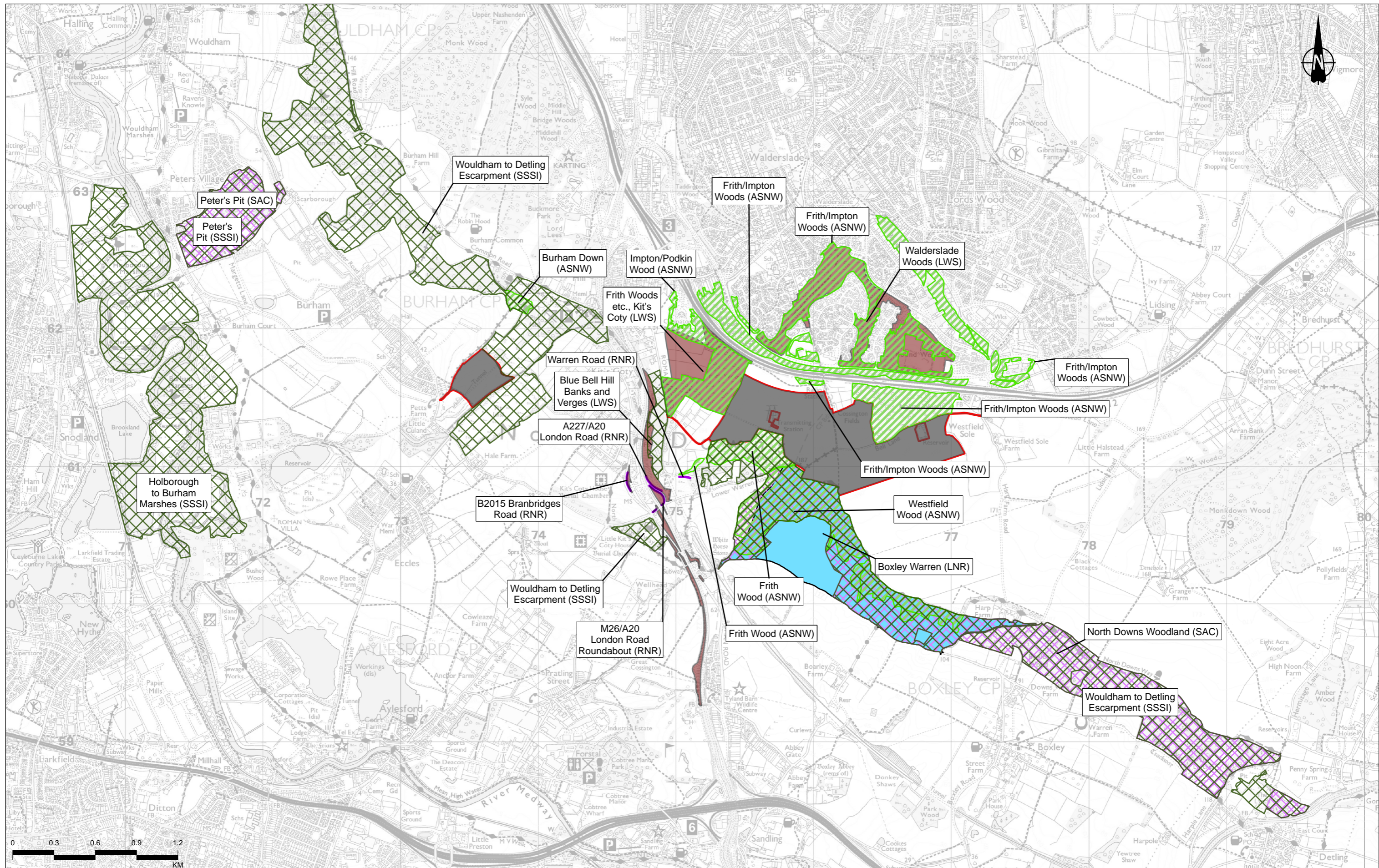
Figure 8.1 - Designated Sites
