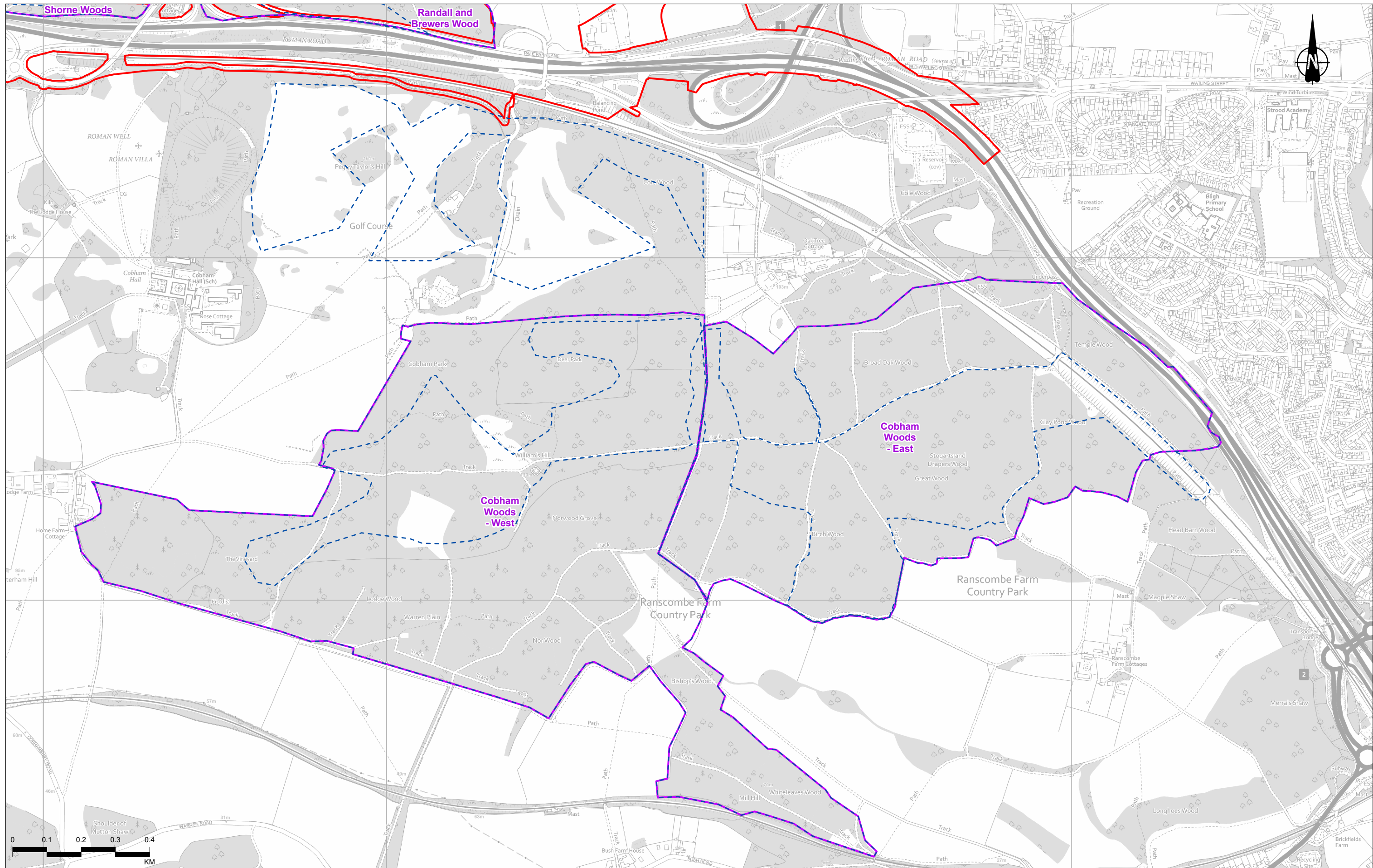
### Figure 8.10 - Ornithology Survey Areas
