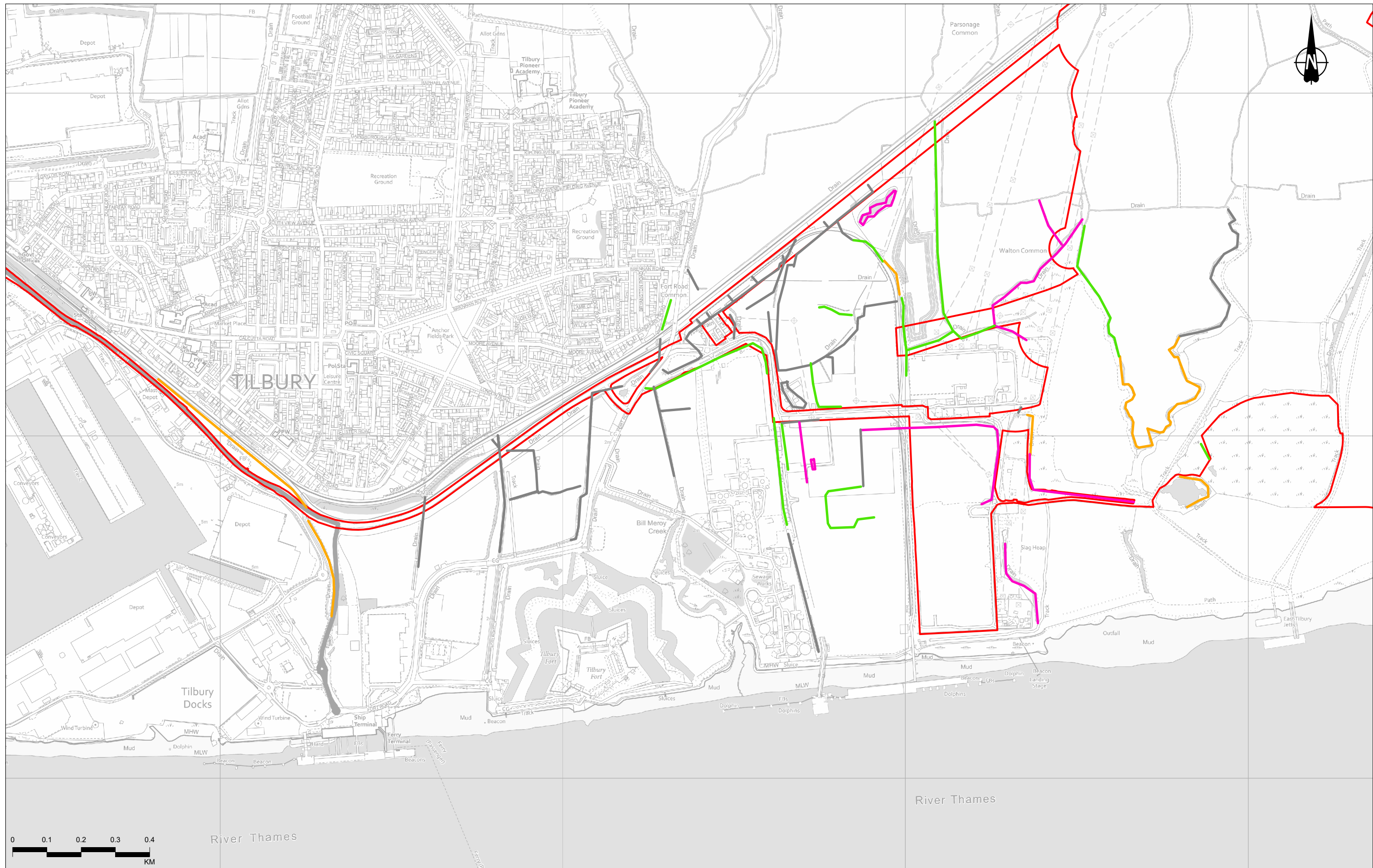
Figure 8.28 - Tilbury 2 Water Vole Survey Results

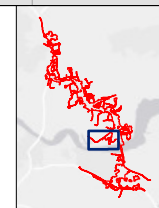
