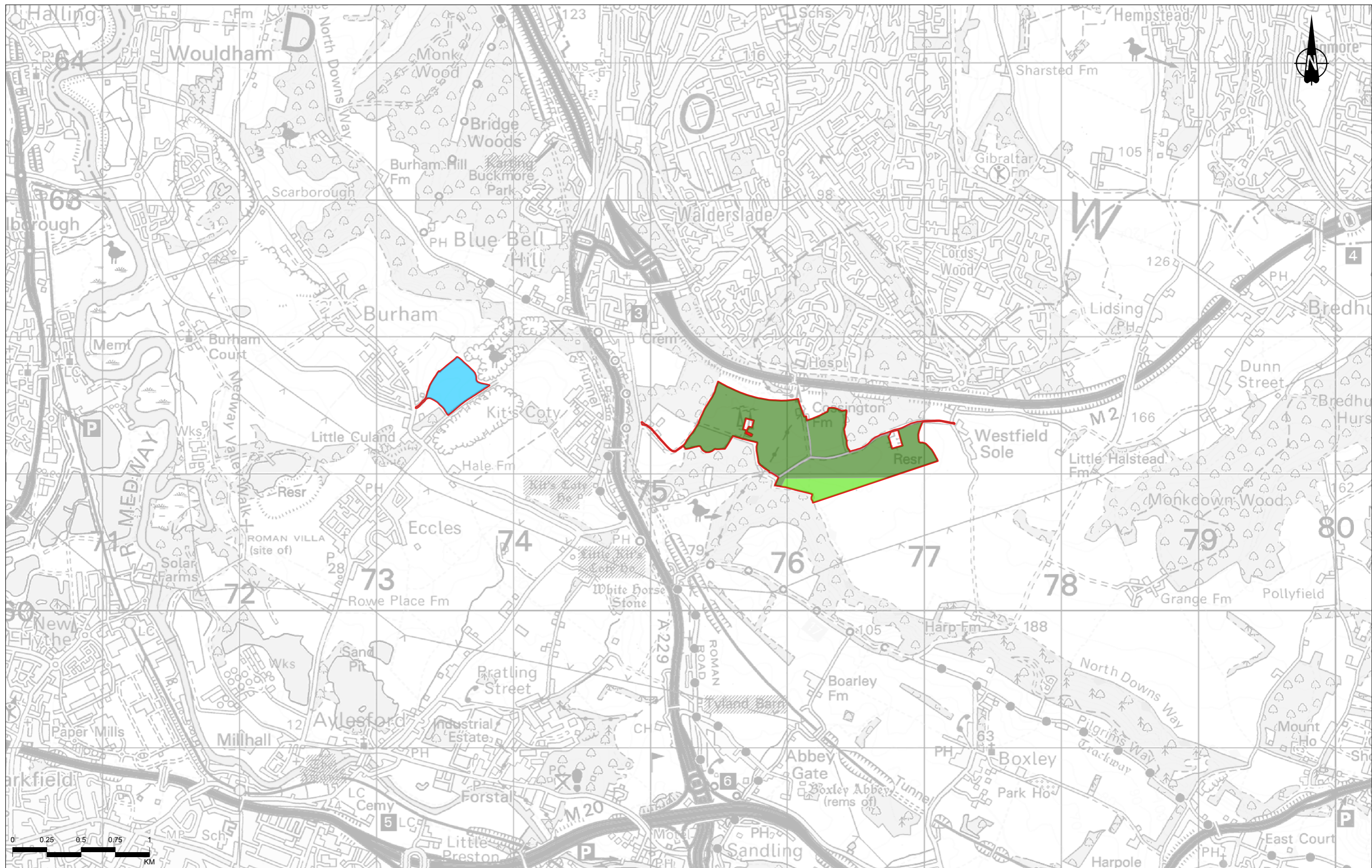
Figure 10.4 - Agricultural Land Classification Mapping
