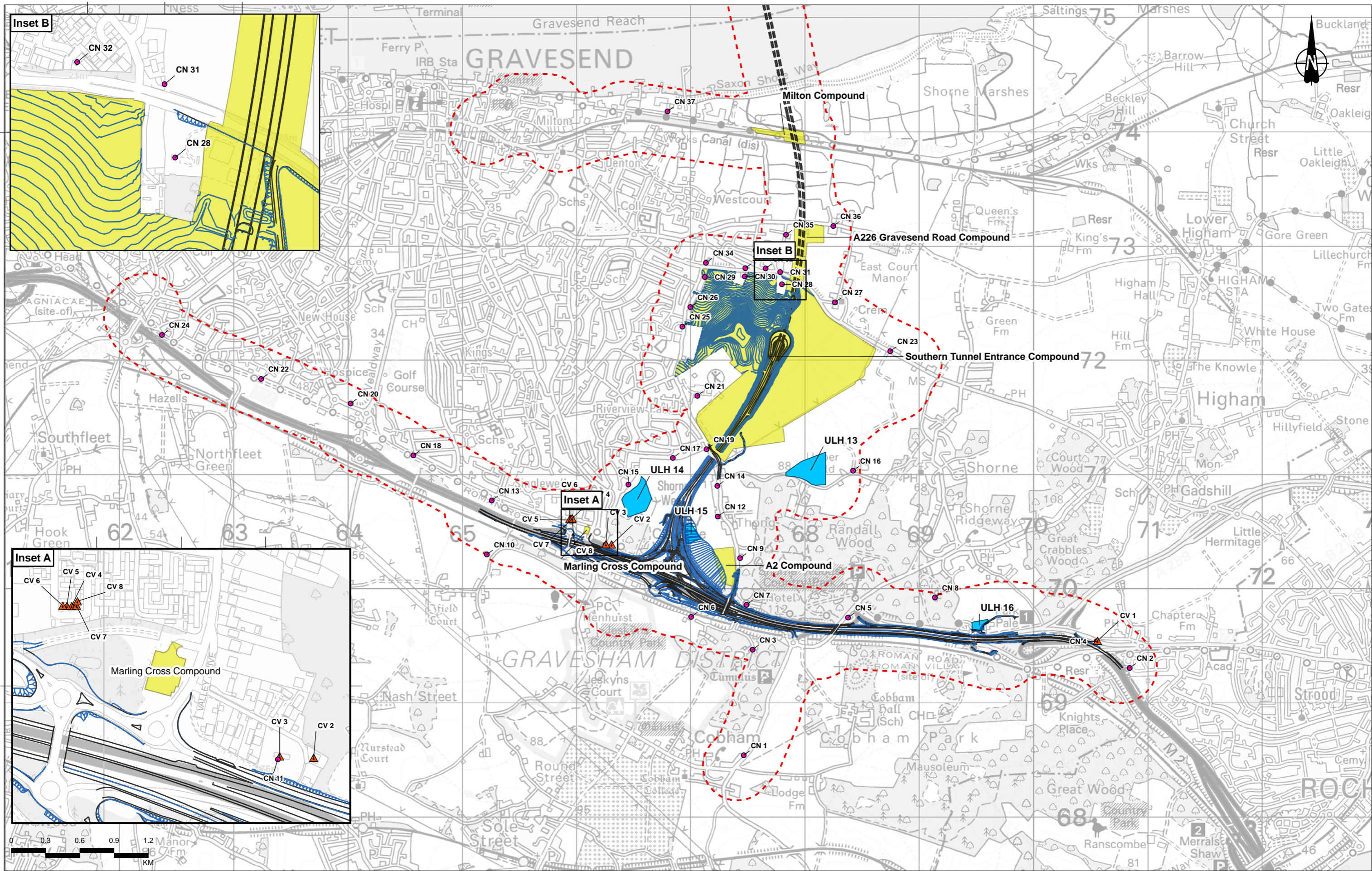
Figure 12.1 - Construction Noise and Vibration Study Area
