### Figure 9.2 - Comparison of common seal locations in the vicinity of the Thames Estuary over three surveys (2013-14)

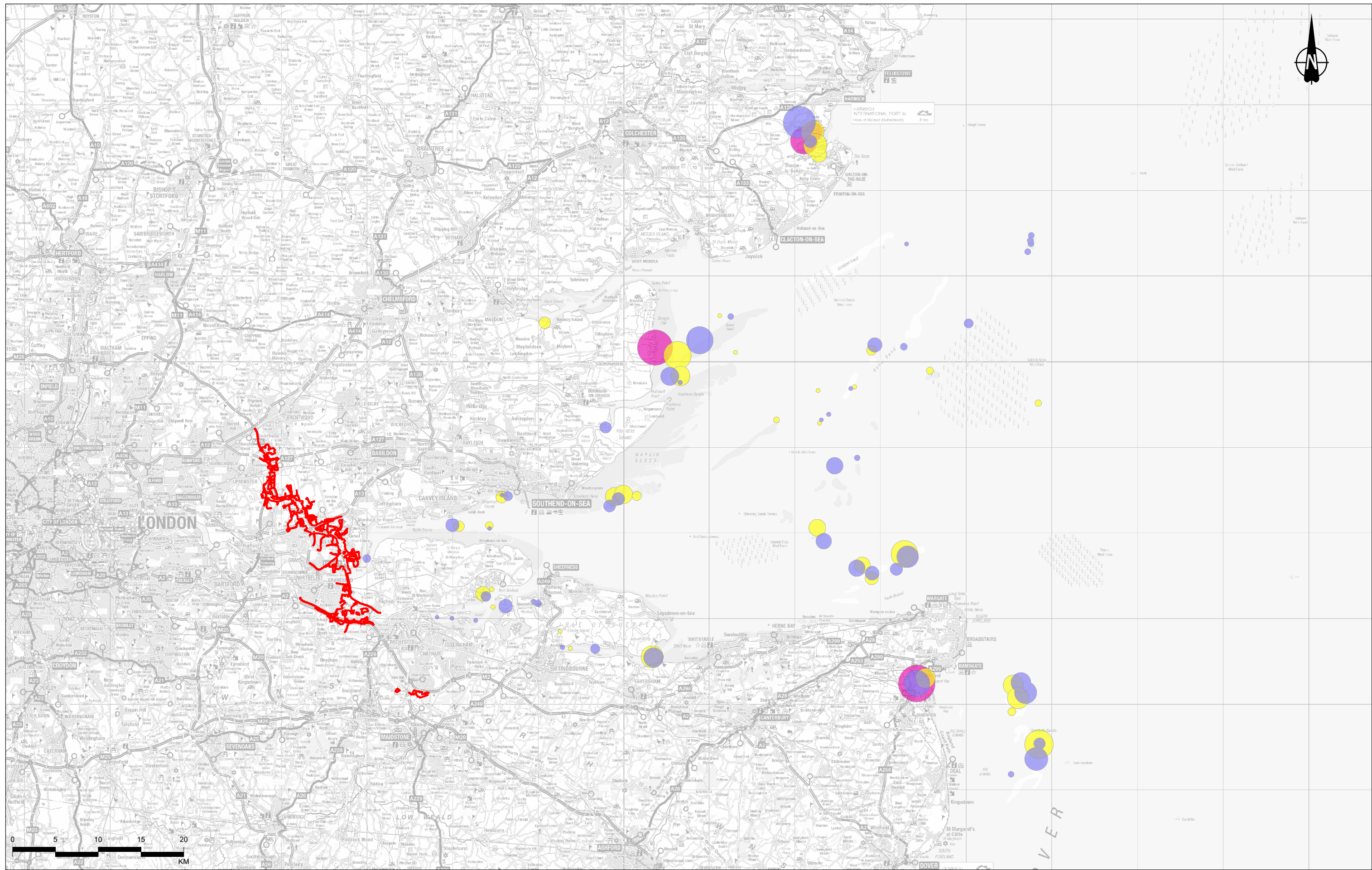

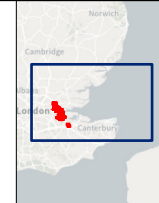
