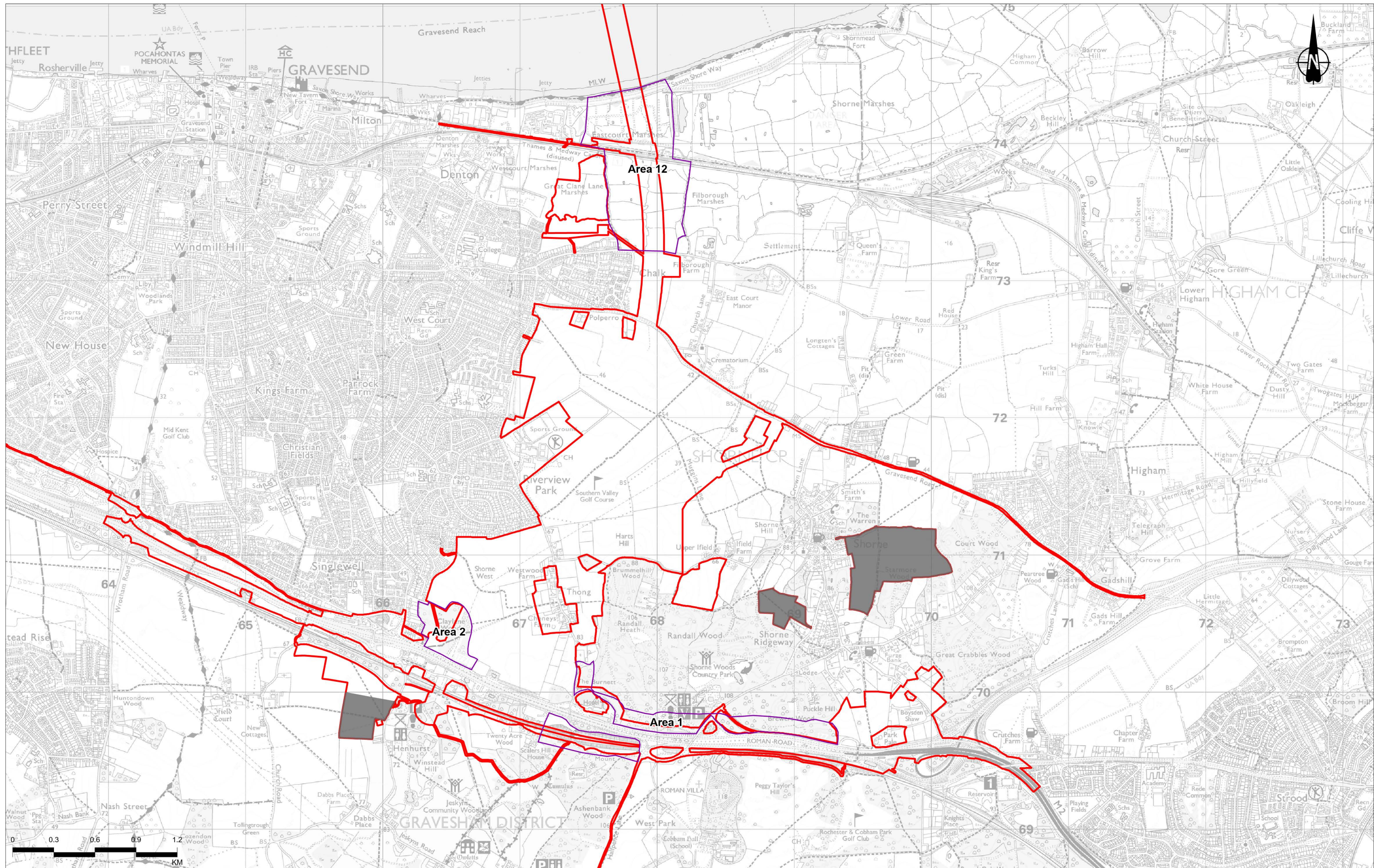
Figure 8.7 - Invertebrate Survey Locations
