in relation to the application for an order to grant development consent for the Lower Thames Crossing Scheme which would be located within ten administrative areas: Brentwood Borough Council, Dartford Borough Council, Essex County Council, Gravesham Borough Council, Kent County Council, London Borough of Havering, Maidstone Borough Council, Medway Council, Thurrock Council and Tonbridge and Malling Borough Council. The Project would provide a new road connection between the A2 and M2 in Kent, east of Gravesend, crossing under the River Thames through two bored tunnels, before joining the M25 south of junction 29, as set out in the plans which accompany the application.

The deadline date for all representations to be received by the Planning Inspectorate under section 56 was 23:59 on 24 February 2023.

During the relevant representation submission period, a limited number of notifications were returned to sender. Schedule 1 identifies instances where this occurred where the parties were re-notified but where the relevant representation deadline set out above could be maintained. In other instances the letter was returned to sender and the applicant had to serve notice at a later stage. Schedule 2 identifies those parties who had return to sender status but were re-notified and an extended deadline of 23:59 on 25<sup>th</sup> March 2023 was set for them to provide them with the requisite period.

In addition, during the relevant representation submission period, two new interested parties were identified, as a result of land ownership changes. Those individuals (identified in Schedule 3) were notified, and provided an extended relevant representation deadline of 23:59 on 24<sup>th</sup> March 2023 to provide them with the requisite period.
