## 1 Errata

### 1.1 Introduction

- 1.1.1 This document is to present any errata that have been identified within the documents that were submitted as part of the DCO Application for the Lower Thames Crossing (the Project).
- 1.1.2 The errors are minor in nature and do not change the meaning of documents, analysis or any assessment.
- 1.1.3 The Errata Report was first submitted with the S51 Submission in December 2023 (AS-004) in response to the S51 Advice issued by the Planning Inspectorate in November 2023 which identified a number of minor errors and omissions (PD-002).
- 1.1.4 As identified in the Rule 8 Letter (PD-018 and PD-020) section 29 it was identified that updated versions of the Errata should be provided at each deadline, or a “nil return” if not required. Therefore, this shall be a live document throughout the Examination which will be updated at each deadline where necessary.
- 1.1.5 Where new a errata item is identified this will be included in this document and clearly identified when it was added into this Errata Report.
- 1.1.6 The errata are presented in Table 1.1, with the correction provided for clarification.

### 1.2 Relationship to other documents

- 1.2.1 In addition to this Errata Report, a Place Name Gazetteer (Document Number 1.7) (AS-005) has been produced to address instances where there are local inconsistencies in the terms of place names used in the area of the Project and where similar place names are used in different locations. This highlights to the reader what these are and confirms the place name that the project is using.
- 1.2.2 This Errata Report should be read alongside the Environmental Statement (ES) Addendum (Document reference 9.8). The ES Addendum has been prepared to outline updates to the following DCO application documents:
- a. 6.1 Environmental Statement (APP-138 to APP-155)
  - b. 6.2 Environmental Statement - Figures (APP-156 to APP-331)
  - c. 6.3 Environmental Statement - Appendices (APP-332 to APP-485)
  - d. 6.4 Environmental Statement - Non-Technical Summary (NTS) (APP-486)
- 1.2.3 It is intended that ES Addendum document remains a live document throughout Examination and would be used to track updates and amendments to the Environmental Statement documents, as these are required.

1.2.4 The following ES documents are excluded from the ES Addendum:

- a. Application Document 6.3 Environmental Statement - Appendix 2.2 - Code of Construction Practice, First Iteration of Environmental Management Plan (APP-336)
- b. Application Document 6.3 Environmental Statement - Appendix 2.2 - Code of Construction Practice, First Iteration of Environmental Management Plan - Annex A - Outline Site Waste Management Plan (APP-337)
- c. Application Document 6.3 Environmental Statement - Appendix 2.2 - Code of Construction Practice, First iteration of Environmental Management Plan - Annex B - Outline Materials Handling Plan (APP-338)

1.2.5 Any errata items identified for those documents listed in 1.2.2 above have not been included in this Errata Report. Where items were included in version 1, these have now been removed and are contained within the ES Addendum (Document Reference 9.8)

1.2.6 For documents listed in 1.2.4, documents a and d are not included within this Errata report because they have been updated and submitted as revised documents for Deadline 1. However, documents b and c are included within this Errata report as they are to be updated at a later deadline in the Examination timetable.

## 1.3 Approach to Errata

1.3.1 The Applicant is reporting these identified corrections through the following documents:

- a. an update on the Errata Report (AS-004) for textual corrections to DCO documents which do not form part of the Environmental Statement.
- a. update to the relevant Book of Plans drawing where an error was identified in the drawings. This will make it easier to understand as no interpretation is needed and there will be improved consistency across the Book of Plans. **Table 3** in document reference 9.1 identifies the Plans which have been updated and submitted at Deadline 1.
- b. document updates – For those documents referred to as control documents in the Introduction to the Application [APP-003<sup>(OB)</sup>] these are expected to be updated over the course of the examination following further engagement with the Examining Authority and stakeholders. Any identified minor corrections will be included within the next document update.

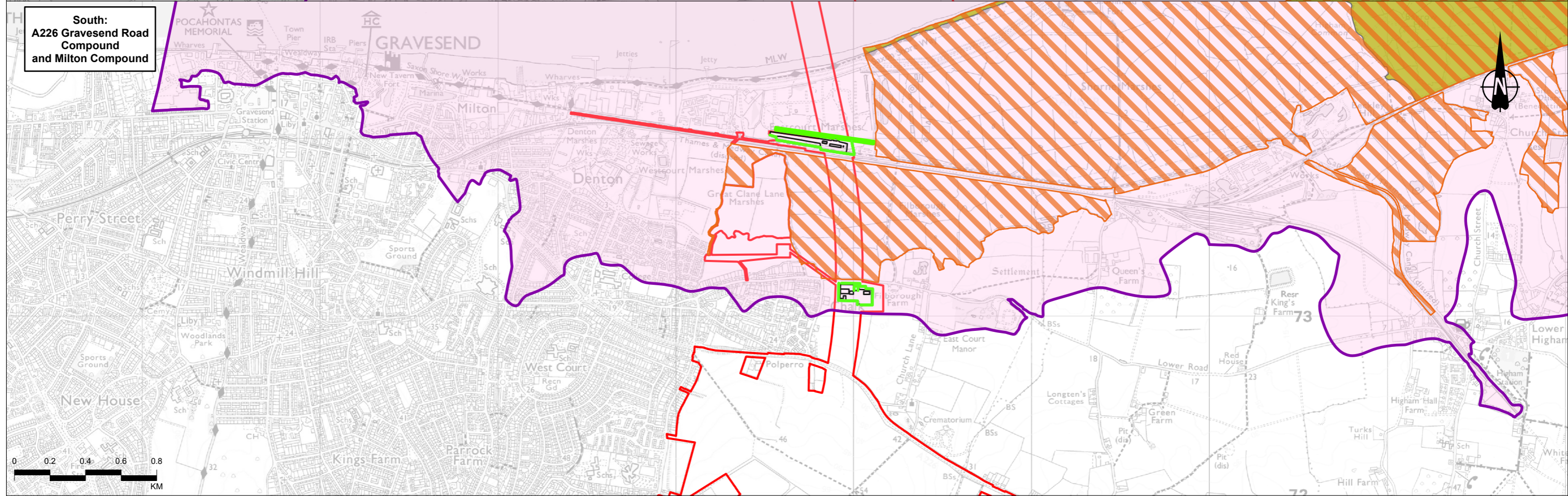
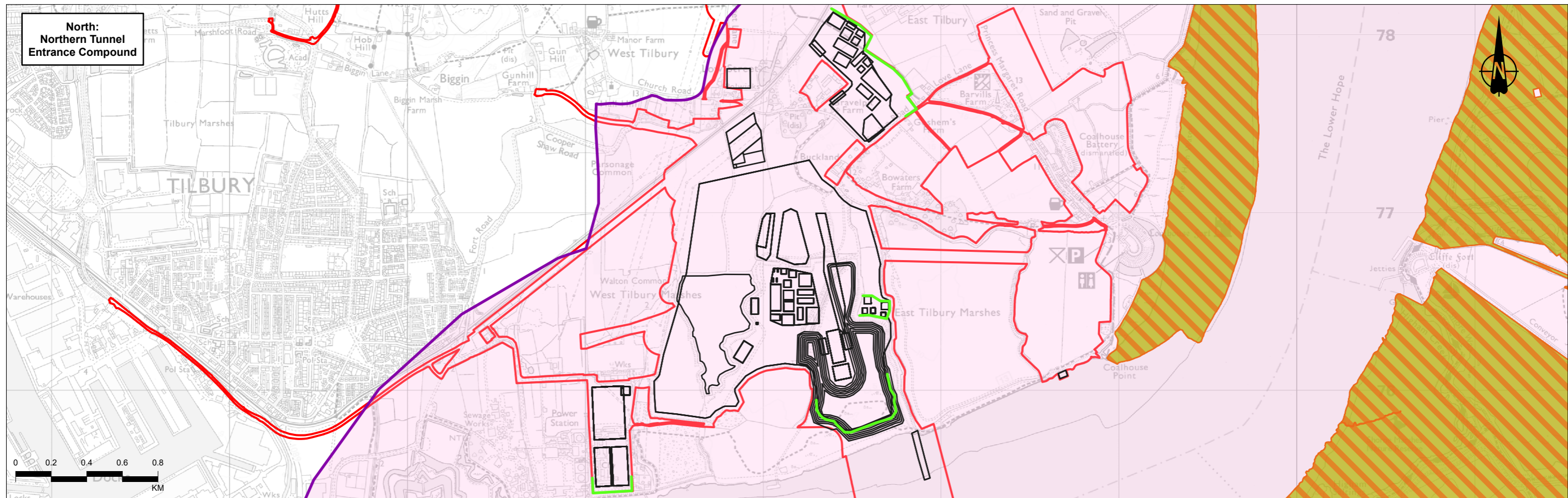

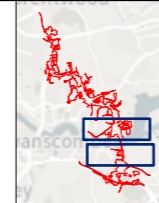
